Keystone school board celebrates high scores in M-STEP assessments

The first thing to do at the Oct. 13 regular meeting of the Keystone Academy Board of Directors was to celebrate the school's high scores on the M-STEP tests taken last spring.

M-STEP stands for The Michigan Student Test of Educational Progress.

"This is the first time we're higher than Plymouth-Canton," said Jamie Steeb, Keystone's dean of middle school and specials who was filling in for principal Jorvanna Drain. Principal Drain was absent because of a necessary trip to the Upper Peninsula.


The M-STEP results had been embargoed, but in a message to parents on Sunday, Oct. 9, Drain wrote: "M-STEP scores have been released. We are extremely proud of our 2021-22 results on the Michigan assessment. We increased our overall proficiency in every subject area (math, reading, science, and social studies) in comparison to the 2020-21 school year.

"For over 15 years, we have academically outperformed the eight local districts that are in the bar graph, but now we are outperforming Plymouth-Canton schools too. We know that there is still much work to be done, but let's celebrate that we have made the tremendous gains despite the challenges we faced during the unprecedented years," Drain said.

Dean Steeb explained to the board that 61% of the students in the tested grades are at or above the benchmark of 50% proficiency.

Later in the meeting, board vice president Steven Harsant asked if there was a way to advertise Keystone's high scores. National Heritage Academies representative Andrew Roth said that would be for NHA to do, but they would probably just enjoy the scores.

"The reason we have this school is because the academics in this area weren't strong," said board president Vesta Losen



who had helped create Keystone Academy in 2003 and has served on the board since its beginning.

Losen said Keystone was able to get the charter from Bay Mills Community College because of the poor academic standards in this area.

Losen pointed out that Keystone had also completed the Fall NWEA testing, which she said many think is a better evaluative tool than M-STEP, and the majority of Keystone students are at or above grade level.

Schoolwide NWEA math scores are 63% and reading 68%. Second graders scored

46% in math and 45% in reading, which she said wasn't good, but grades 3-5 were 67% and 72%. And, grades 6-8 were 65% and 72%.

In other business at the one-hour-and-36-minute meeting, the board:

• Heard a lengthy report from Dawn Bandy of the PTO, asking the board to help cover bus transportation for students to go on field trips. The PTO usually helped the school by providing transportation but with rising costs, including higher entry fees, and fewer fund-raisers they needed help. The board voted unanimously to provide up to \$10,000 to support field trips. Roth said he

would talk to NHA about getting funds to reimburse the board for this. Up until about five years ago, parents would drive students on field trips, but now that is not allowed. Such parent driving was suspended after a parent on a field trip took a carload to McDonald's for an hour and got lost; and

• Approved providing \$12,000 to pay athletic coaches and athletic director, \$1,500 to purchase items for the school store where students use the Keystone Cash they've earned by exemplifying Moral Focus virtues and positive behaviors, and \$3,200 to reward staff that go above and beyond their normal duties;

That *View* also contained a story about the dedication of the renovated Victory Station in 1991. We photocopied the story and gave it to Belleville City Manager / Police Chief Dave Robinson for his files. After he saw the story with all the information on the park and what once was a county Comfort Station, he said the city should put the information into a plaque to put on the wall of the renovated Victory Station after he gets the grant to do the work.

Sumpter Township fire fighters took it in stride when they got a run in the middle of their open house on Saturday. They were called to a medical run at Rawsonville Woods and a crew got into a small unit and took off on the run. There were still lots of fire fighters on hand to host the visitors to their fire hall to mark National Fire Prevention Week.

I remember when Chesley Odom designed that fire hall and at the time he was criticized for making it too beautiful for a rural fire department. I disagreed, as did Supervisor Marvin Banotai who wanted something special. It is gorgeous and still brings admiring remarks from passers-by. They've had to do some maintenance in recent years, but that's part of life.

Crain's Detroit Business had a frontpage story in its Oct. 10 edition about the \$952 million in state incentives recently announced for two EV battery factories: one near Big Rapids and one in Van Buren Township. They are expected to bring 4,462 jobs between the two of them, which amounts to \$213,357 in taxpayers' money per job. Ouch.

Belleville Mayor Kerreen Conley talked about last weekend's marathon in Detroit

after Monday's city council meeting. She said it was great to see the parts of Detroit that had been upgraded and beautified.

The course of the Detroit Free Press run was changed to include

these areas. She didn't go into Canada and back like some did but she did some legs of the run.

Brad Traskos told me he failed to ask Van Buren Township Police for help with traffic for his Oct. 8 tractor parade in and out of Belleville, and he should have. He ran into bad traffic on East Huron River Drive. He told the Belleville City Council on Monday that drivers going 80 miles an hour were trying to pass the string of tractors and when they saw another vehicle coming, turned into the tractor lane. It was hair-raising, he said. He will ask VBT for help next year. He also wants to change the route to put the route home to Sumpter via Elwell.

Police arrest high school student with loaded gun at school

On Wednesday evening, Oct. 12, the Belleville High School administration was notified that a current juvenile student posted a video of himself brandishing a firearm on social media.

It was undetermined at the time when the video was taken, however, it was clear the video was not taken at school, said a Friday press release from Belleville Police Chief David Robinson.

The Belleville Police Department was notified. Out of an abundance of caution, the Belleville police worked with school administrators and security staff and the juvenile in question was located as he arrived at school on Thursday, Oct. 13, at about 7 a.m. The student was detained and upon searching a loaded firearm was recovered on his person. The student was immediately taken into custody without incident, the press release said.

The results of the initial investigation

concluded that the student did not have any intent to do harm to any student or faculty at the school, Chief Robinson said.

The student was taken to the Wayne County Juvenile Detention Center on Thursday because he was a juvenile at age 17 years, 4 months. He was released on

Chief Robinson said he would like to thank the quick response by school administrators and his officers for the appropriate response to safely mitigate this situation.

WWJ Radio reported, "According to school administrators, the student told officers he was carrying the weapon to protect himself due to an ongoing neighborhood conflict."

WWJ said according to school administrators the student told officers he was carrying the weapon to protect himself due to an ongoing neighborhood conflict. Police sought out and removed the other students thought to have been involved in the conflict.

A parent meeting was scheduled at 6 p.m.

Thursday at the BHS Commons for parents and school officials to discuss the incident.

School Supt. Pete Kudlak said various news crews present for the meeting were kept outside and told they could talk to the parents entering and leaving the meeting, but not be in the meeting.

Supt. Kudlak said all three gun incidents at BHS stemmed from the same violent incident in April in West Willow neighborhood in Washtenaw County, which is within the school district boundaries.

He said Washtenaw County Sheriff's Deputies were at the parent meeting and explained how they have been working to solve the problem, even putting people in

"The kids don't know how to handle it," Kudlak said. He said the violent issue was not between kids but spilled over to them. He said it wasn't a drug issue.

He said police from Washtenaw County will be present at an upcoming school board meeting to discuss the West Willow

On March 7, a 15-year-old student was arrested at BHS after a loaded gun fell out of his clothes while changing in a restroom. A parent meeting brought 100.

On April 21, five students were detained after a loaded firearm was found in another juvenile's book bag. The gun was found

outside the school, but that student had been in school for five of the six hours of school that day. About 50 came to that aren't meeting.

At the time, Kudlak said the students found with guns on March 7 and April 21 both live in Ypsilanti Township within the school district. The other four in the April 21 incident live elsewhere in the district.

At the April 25 school board meeting. board president Amy Pearce said the two students in the March and April gun incidents come from Ypsilanti Township and they are scared to get off the bus and walk home safely.

Another violent incident happened in West Willow on Sunday and, according to police, the student involved in last week's gun possession was suspected to be involved.



Abortion amendment and ectopic pregnancies

Proposal 3, an Abortion Constitutional Amendment, will be on the ballot this November. For the following reasons, Michigan voters should reject this measure.

Those who support Proposal 3 falsely claim that without this amendment, women will not be able to seek medical care for ectopic pregnancies and miscarriages. But this is entirely fallacious.

Ectopic pregnancies, or tubal pregnancies, occur when a woman's ovum is fertilized and implants in her fallopian tube, which occurs in about 2% of pregnancies. Under these circumstances, the baby cannot survive and there is no known procedure for rescuing the child. If allowed to develop, this condition will also be fatal to the mother. In order to save the life of the mother a surgeon must remove the embryo. However, this procedure is not, and never has been, considered a medical abortion by any state in the country. The intent is to

save the life of the mother. If a procedure was known to also save the life of the child, the medical professionals would do so. Saving the life of the mother is very different from elective abortion.

Restrictions on elective abortion would have no effect on the availability of medical care for women with ectopic pregnancies.

Supporters of Proposal 3 also claim that restrictions on abortion would limit a woman's access to medical care should she miscarry during her pregnancy. This is also false. A miscarriage is when a woman's baby dies from natural causes while she is carrying the child. If the body of the child is not medically removed from the mother's womb she will likely suffer serious medical complications. For these reasons, the baby's body is usually removed. However, this is very different from requesting that an abortionist intentionally kill a living human fetus.

Restrictions on elective abortion would have no effect on the availability of medical care for women who have miscarried.

However, passage of Proposal 3 would give us the following:

Repeal of parental consent and informed consent laws for abortion.

Repeal of ban on taxpayer-funded Repeal of health and safety regulations

on abortion clinics. Repeal of law requiring that only doctors

can perform abortions. Repeal of partial birth abortion ban.


