## Public invited to study proposed City Master Plan

At Monday's regular meeting of the Belleville City Council, the public was introduced into the 120-page proposed new City Master Plan by planning consultants from Giffels Webster.

A man in the audience said the new Master Plan wasn't available for the public to see to comment on, although members of the city council had copies.

After discussion, the council voted unanimously to formally authorize distribution of the plan to surrounding communities and other entities for 63 days. Then the planning commission will hold a public hearing, probably at its March 12 meeting, and make a recommendation to the council for approval.

The vote on the distribution came during the public hearing and before the 15-minute hearing was closed. Most of the comments on the plan came from the consultants and the council, since the public didn't have a copy of the plan.

The draft Master Plan will be available to the public for review at city hall, the Belleville Area District Library, and at the city's online site. Directions on how to comment on the plan will be included in the draft.

Eric Coppola of Giffels Webster said this is the first complete rewrite of the city's Master Plan since 2006. It has been updated regularly since then, but now it is completely redone.

Under state law the Master Plan must be at least updated every five years, said consultant Andy Aamodt.

Coppola said at least eight of nine meetings of the planning commission over the past year have included discussion on the Master Plan. There also have been several public-input surveys.

## BHS Robotics Competition 'game reveal' set for Jan. 10

Like any other sport, FIRST Robotics Competitions open each season by fielding fresh teams, advancing through brackets, and, for an elite few, closing with best-of-the-best facing-off during national or international championships.

Unlike more familiar legacy counterparts that square-off on diamonds, gridirons, and courts, however, the appearance of contestants and very goalposts and fields of play are different every year for student-developed robots.

This Saturday at noon Eastern, umbrella organizer FIRST Inspires is slated to detail exactly what that will mean for 2026.

Hometown Team 6615 "Bellevillains" and their advisors will be on-site at the high school to watch the "reveal" simulcast live. That, too, will be their chance to download literally hundreds of pages of documentation for this next game -- the only clue to which thus far is its name: "Rebuilt."

Initial matches come along on the calendar in early March, leading some to see Jan. 10 as starting pistol.

But insiders know better.

Three weeks ago, with just one day left before holiday break, a half-dozen *Bellevillains* and BHS robotics coach Aaron Watkins participated in an after-school press backgrounder with the

*Independent*. A leading point of emphasis was that the most effective teams view robotics as 12-month engagement.

Thus, Taste of Belleville visitors may have noticed the local team table set up near Horizon Park. Students were there to promote this "STEM-oriented" activity, explain it — and ask for financial support.

"This is a very expensive sport," one student said. Budgeting for 2026 is expected to range from \$20,000 to \$30,000. Going into matches, Bellevillains will plan to have up to \$7,000 in parts alone on-hand. Participation in each match comes with price tags, too.

For those "elite few" who merit slots at

### Parks and Recreation Plan

A second public hearing was held on the draft of the Parks and Recreation Plan. Mayor Ken Voigt said the notice of this public hearing had to be published 30 days in advance and it wasn't published in time. He said it was published Dec. 18 so the plan was to open the public hearing at this meeting and extend it to include the next meeting on Jan. 20.

Consultant Coppola said in order to be able to get state funding for park projects, the city has to have a Recreation Plan. He said they got six responses to a survey on the draft and after a special meeting for input, the total responses was up to 15, which he said was "acceptable for a town of this size."

He said the deadline to send the approved plan to the state is Feb. 1.

The public was told the Recreation Plan has been online for review.

Mayor Voigt said the city wants to submit a grant application for ten more boat docks at Doane's Landing park.

He said a \$750,000 grant to improve the banks at Horizon Park was received and is now in the hands of the city's engineers.

Mayor Voigt also said the city wants to submit a grant application to the state to improve the city boardwalks.

Several people in the audience commented on the Recreation Plan, with many wanting better water quality in Belleville Lake. It was noted the city has no power over the water quality, but could partner with Van Buren Township, Wayne County, and the State of Michigan to help with support groups.

The 24-minute public hearing closed and will reopen on Jan. 20.

In other business at Monday's meeting, the council:

- Heard an update from interim city manager Steve Jones on work at the new city hall at 330 Charles St. He said he believes all the staff took a tour of the building. He referred to a document he had distributed to the council, but not the public or the press. He mentioned a figure of \$175,000 and that audio-visual and updating of computers was needed. He said work at the building has been quiet over the holidays and the door jams are coming any day now and then the floor can be laid. He guessed they could move in in mid-February;

- Heard councilwoman Julie Kissel say the shelves and desks intended to be moved to the new building have disappeared. Jones said they were put into storage until they could be brought into the new building;

- Heard DPW Director Nathan Johnson report the pre-construction meeting on the Liberty Street Project will be held the

next day. He said letters will be sent out to residences of the area under construction to tell them what will happen and when, such as water shutoffs and directional boring. He said law requires pressure tests and chlorine in the pipes for so long before putting the pipes into service and abandoning the old pipes. Mayor Voigt said the original bids were a half a million dollars more and so they saved money by rebidding, as recommended by the city engineers. He said this project includes adding a fire hydrant every block. Now there are just two on North Liberty St.;

- Heard the mayor remove from the agenda, without comment, a discussion on Tax Incentives for city economic development and a discussion on Civil Service;

- Noted since city hall has been closed over the holidays there were no accounts payable, departmental expenditures, budget reports or any reports from police, fire, or DPW; and

- Went into closed-door session with the city attorney for two items not available for the public to know.

the "World" championship starting at the end of May, travel and lodging costs for Houston, TX, will have to be plugged-into their accounting. Add more money to cover robot packing, shipping, and handling.

Way back when, local leadership recognized the need for enterprise-level thinking from the get-go.

FIRST Inspires was founded in 1989; Belleville entered its first robot in 2017, at the high school level. Attention in the Van Buren Public Schools then quickly prioritized launch of a local "FIRST Tech Challenge" team, which allowed students to join that as early as grade-seven. Next, they primed-the-pump to create a "FIRST LEGO League" team -- which meant introducing youth concepts as early as Kindergarten.

This has had the effect of shortening learning-curves and equipped incoming Belleville High School freshmen to hit-the-ground-running as thought- and leadership-contributors en route to FIRST Robotics Competitions.

Concurrently, nascent investments here were deployed to secure position as a host venue for competitions. That was critical to developing and perpetuating whole-of-community involvement.

"We know it's not easy to figure out scoring for our matches," one BHS robot programmer told the *Independent* just before Christmas.

"Is my team winning?" When you're in the stands, and you see things happening, that brings you into it. That helps you 'get

it.' Then your mind begins to get a place to put 'scoring' and you can figure out why your team is going to advance or if it isn't going to advance -- even if you still aren't exactly sure how the scoring got to that. But you see that it's fair."

Those "stands," by the way, are the same ones currently occupied this season by Belleville Tigers basketball fans.

Today, just like in the early days, teams can purchase "kit robots" produced by FIRST Inspires. Kit robots comply with all criteria of the current reveal (presently, "Rebuilt"). These can be especially helpful to newcomers, lowering barriers-to-entry by reducing the load on hardware specification deciphering, design, and fabrication time. "Some assembly required" kits, then, equate to more time down the road for programming and driver training.

Despite almost a decade under their belt, Bellevillains will acquire a 2026 kit robot -- to support their own newbies. In fact, a dated 2025 piece has continued to serve as an orientation platform for the past several months leading up to Jan. 10.

At the same time, lest readers be led to believe that the last almost-decade has been an all-success, linear climb, coach Watkins briefly revisited the humble beginnings of what is now Team 6615.

"We did not do very well at all," he said. "I remember one robot that was supposed to be built to fit within a certain cube of space. They always have to. And ours did -- in its base configuration. But not when it was deploying. The judges were nice enough about it. But we couldn't go forward with that, and things got a lot harder, really fast -- right there during the event."

Back at that time, the sum-total Van Buren Schools contingency amounted to eight students. And, thankfully, peer-to-peer support is root-DNA under FIRST

Inspires. So other, ostensibly competitor teams stepped forward with offers to assist.

"This is *not* 'BattleBots,'" one Bellevillain operator emphasized to the *Independent*. "You don't make your robot to destroy other robots. You don't try to knock other ones over or make them lose by damaging them. You don't win by blocking."

A second student elaborated: "If another team needs parts, you help them; you lend them parts." An important part of Team 6615 gangbox preparations includes stocking parts in considered anticipation of what might be needed for robot correction or repair by other teams in the field.

Beyond the team, that's broader, self-imposed Tri-community culture when serving in its role as host facility.

Collaborative field of play may be difficult to visualize for anyone brought up with sports where a yard gained by one side requires a yard lost by the other. Yet, putting that mindset aside does not mean lowering the bar on objective performance metrics. "Efficiency" is the key to advancing into State contests, the *Independent* was advised.

But the Bellevillains course has not been limited to mere reflexive claims of promised results. Juxtaposed against those first couple of years, the last two have seen BHS Team 6615 advance as far as World competitions each time.

And, as the 2026 season, proper, gets under way, the Bellevillains contingent now numbers about 35 students, plus eight to ten mentors. One of those is currently working toward a college degree in computer science. Prior to that -- full circle -- he, himself, was once a Bellevillain.

## Sumpter OKs \$247,230 to rehab Martinsville Pump Station

At its Nov. 12 regular meeting, the Sumpter Township Board of Trustees approved a bid award of \$271,953, plus 10% contingency, to Lawrence M. Clark to rehabilitate the Martinsville Pump Station. The total amount is \$247,230.

In other business at the 41-minute meeting on Nov. 12, the board:

- Welcomed Pastor Jim McKinnis of Willis Baptist Church to pray over the meeting before it began deliberations;

- Approved the low bid of \$5,100 from VanAsche to clean up the blight at 47750 Wear Rd., per court order, cleaning up

everything and leaving the house. The other bid on the job was \$8,100. Township attorney Rob Young said the board had passed an ordinance and the township went to court where on Oct. 21 Judge Brian Oakley ordered a cleanup within 30 days. Young said there has been no action to clean up so far. The cost for cleanup will go on the property tax and the township could foreclose on the property. Police Chief Eric Luke said the low bidder could also clean up the blight on two other properties while its equipment is here and that will be considered;

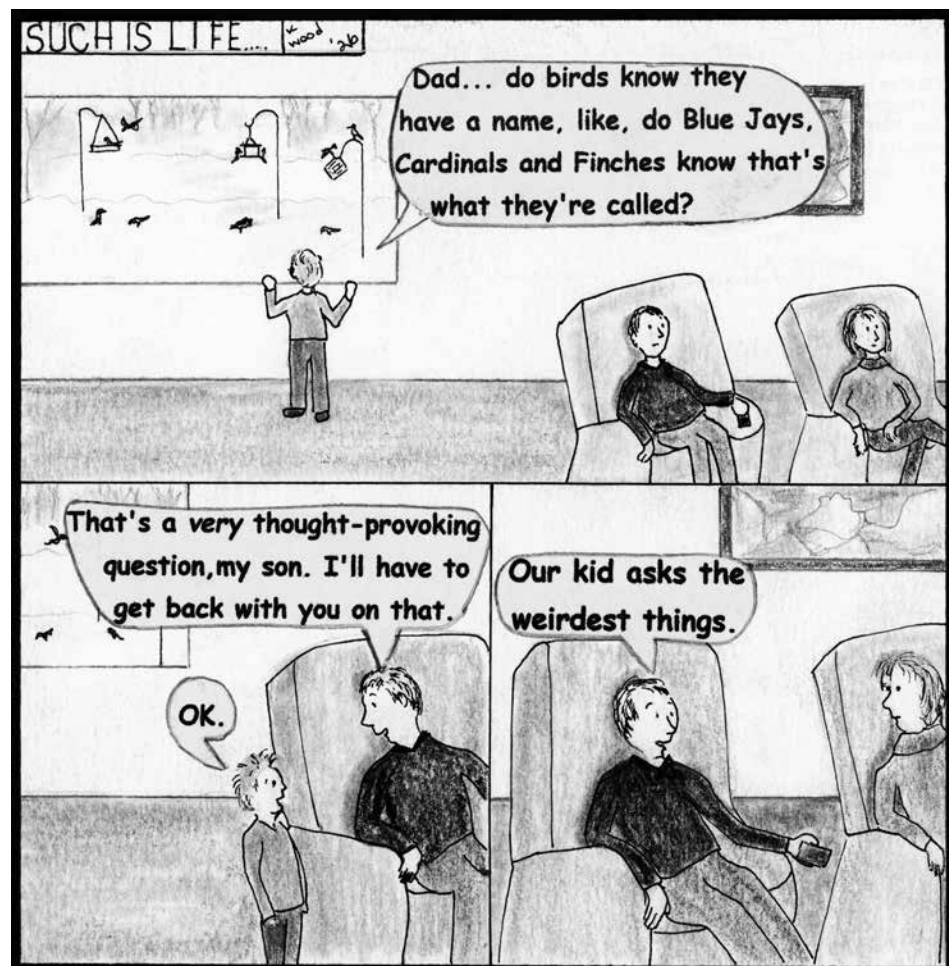

(so far). The problem continued and I, once again, confronted these men. I asked why this has continued – no answer. I asked the name of their employer and address – they had no idea of whom pays them!

Now, the next snowfall, Dec. 1, I went out to shovel away the several inches of snow to see that the machine used next door had been driving back and forth, several times, over our front sidewalk (along the street) thus packing/smashing down the snow over and over, deeper and deeper, firmer and firmer.

I wrote to the neighbor informing of this cruel action. An action of anger, hate – even a threat of "how dare I" and "try confronting us again."

It's now nearing a full month since the letter.

Please, mail me the info I asked for. You have my name and address. As writing is the only way to "communicate" with you, so I will only receive the info from you via letter/mail. If you feel I don't have the right to this info, write and tell me why. Thank you!

With respect, I write this and request my name be withheld so to keep your name and address private.

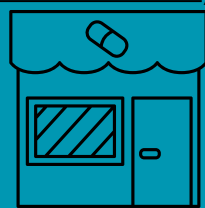

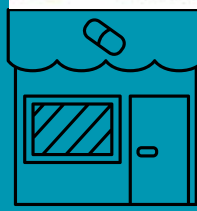

## Remember activities in Tri-Community in 1996?

At this quiet time of year, we can look back to see what happened in the past to bring this present time into being.

**These are stories from the Jan. 4, 1996 issue of the Independent:**

There was an open letter from the Independent on the front page to each member by name of the Van Buren Township Board of Trustees asking them to direct their Public Safety Director Mark Perkins to uphold the Constitution and provide police news to the *Independent* as it regularly does to *The View*, the *Ypsilanti Press Edition of the Ann Arbor News*, and the *Belleville Enterprise*.

It has been 11 weeks of Director Perkins' news blackout. Perkins told us a seminar speaker said police do not have to speak with a reporter they do not like (ie. does not report the way they think it should be reported). We have just one reporter, so that is a problem.

\*\*\*

Homeowners in the Lake Crest Subdivision on the north shore of Belleville Lake in the Harmony Lane area are considering re-energizing their homeowners' association to fight the houses which suddenly have appeared on two neighborhood lots.

According to reports, A Taylor speculator purchased two or three lots in the

neighborhood, at about \$40,000 each, and is moving homes from the Metropolitan Airport construction area to Van Buren Township. One small home is on Fisher Drive and a large home is on Harmony Lane.

A reader furnished a picture he took out of his front window on Dec. 21 that showed two houses and a garage going by even though the subdivision covenant prohibits such homes from being moved into the area.

Page three showed five pictures of the 60<sup>th</sup> birthday party thrown by Barbara Rogalle Miller for her brother, Lawrence, at the Eagles Lodge. Lawrence, a special needs person, was a member of the Eagles.

Inside on page six, an article by Dee Crowe tells of the fun of running all year round, especially when the temperatures are below zero. She cites books that tell people not to do this, but she suggests the reader give it a try. She said up to 30 BBC Striders run all year long and she provided a phone number readers can call for more information.

On page seven, there was a report on a Van Buren Township Planning Commission meeting where auto auctions were discussed. Darrel Ibach had asked for a rezoning of his property of about seven acres at 13000 Haggerty for a Pro-Tech business to hold auto auctions. He learned he already could have indoor auctions under the present zoning, so he withdrew

his request. Amendments to the zoning ordinance were suggested to allow outdoor auctions. Meanwhile, Pro-Tech opened as an indoor-only auto auction.

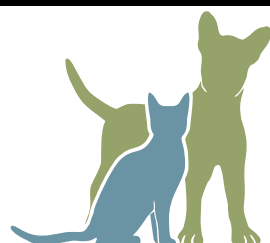

to bring \$100 to bail out his minor son who was arrested by VBT police for soliciting without a license. The boy worked for Home Window Company in Westland and was with youths that would be let out in a neighborhood and go door to door, asking residents if they were interested in replacing windows. If they were, the youngsters would send a salesman to talk to them. The teen had been working for them for two years.

Kaye, a union steward at General Motors and a former police officer, learned the

officers had arrested his son while walking to the company van and had not observed him soliciting. As a former police officer, he said he knew the arresting officer had to observe the solicitation personally for a misdemeanor arrest without a warrant.

According to court documents obtained through FOIA by the Independent, Kaye said he asked one of the officers to go outside to discuss the matter. After less than a minute outside the officer reentered the building and warned Kaye not to reenter or he would be charged as a disorderly person. Kaye reentered and that's when he was attacked, he said. He said he was kneed in the chest and his rib broken among other injuries. The charges against him were dismissed before he was due at 34<sup>th</sup> District Court.

On the back page, was an ad for Huron River Food Market, a packaged liquor store located next to the Belleville Police Department on E. Huron River Dr.

One dozen large eggs was 49 cents, loaves of bread were two for \$1.49, half-gallon of ice cream was two for \$3, and Pepsi and Coke were 99 cents each for a warm, two liter, plus deposit.

Robert Costica Bonas of Sumpter Township was video-arraigned in custody on Dec. 15 on charges of assaulting / resisting / obstructing a police and driving while intoxicated on Aug. 30, 2025 in Sumpter Township. Bond was

set at \$5,000/10% and a probable cause conference set for Dec. 22. Preliminary exam was set for Jan. 2, but removed from the calendar. Instead, another probable cause conference was set for Jan. 2.

At that time, he pled guilty to reduced charges of police officer assault and the second charge of driving while intoxicated. The OWI plea was sent to probation for a recommended sentence.

### Sunshine Wallace

Sunshine Wallace of Van Buren Township was video-arraigned in custody on Nov. 14 on a charge of domestic violence on Nov. 12 in Van Buren Township. Her personal bond was set at \$5,000 and a remote pretrial for Dec. 10. She is not to return to the protected address.

removal with Community Development Block Grant funds, with revised specifications;

- Approved a volunteer policy and application form;

- Approved a \$3,500 contract with Plan-it, noting the BS&A version would be more expensive;

- Received no support for a motion to transfer Accounts Payable and Payroll oversight from the Clerk's office to the Finance Director. The motion died;

- Received no support for a motion to approval fiscal year 2025-26 2<sup>nd</sup> Quarterly Budget Amendments as presented at the Oct. 28 meeting of the board. The motion died;

- Approved closing township hall from 11:30 a.m. to 1:30 p.m. for the annual employee holiday luncheon on Thursday, Dec. 11;

- Heard treasurer Patterson praise the veterans' ceremony at Belleville High School on Nov. 11 and noted they need to get more youth involved and should promote it next year so more people will come;

- Heard attorney Young say he has been talking about retirement, but he suggested the township just have him and another attorney work together. He said there is so much more to know these days and there is more than one person can handle. They could take turns coming to the meetings;

- Heard Hassan Nassar complain about a letter in the *Independent* that said there was no American flag on the Hughes building now that he bought it. He said he was called an "outsider" but he has been in various businesses in Sumpter for 35 years. He said he did not take the flag and somebody else took it during the changeover from Hughes to his ownership. [Note: Now there are many flags.];

- Heard Zeola Walker say Sumpter residents welcome all businesses to the area, but they don't want all junk yards. She said Nassar has two now and another one was requested. She said she served on the planning commission when the original market request turned into a pharmacy and then turned into a gas station. She said she plans to be around a lot longer to keep watching things;

- Heard township manager Ken Marten report that the Environmental Protection Agency is working to clean up a property on Savage Road. It was granted a landfill permit in 1974 and now there is 10 to 40 times more than the safe amount of lead on the property;

- Heard Marten say he was ill and didn't attend the last township board meeting when the township logo was on the agenda and not approved. He said the committee working on the logo said the township has a farming heritage so the wheat, tractor, and color green and gold/brown reflect that. He asked for direction forward on completing the logo. He said this project was under way before he became manager; and

- Was advised the township has a 28-page technical report on the penetration test, which shows vulnerabilities in the township computer system. Trustee Rush said he thought that report should be kept confidential because public release could harm the township.

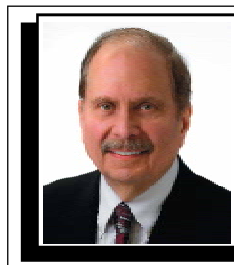

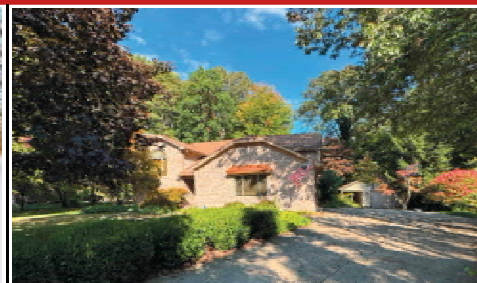

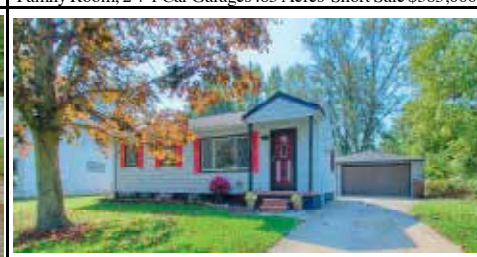
