# Council votes 4-1 to hire advisor to run fire dept.

After another lengthy discussion on the fire department, the Belleville City Council at Monday's regular meeting voted 4-1 to hire an outside advisor to direct the fire department for three months at a cost of \$5,000, starting Dec. 1. The time period could be extended.

Mayor pro-tem Kelly Bates cast the only no vote.


The council was about to vote on the proposal by interim city manager Steve Jones, when Bates asked for the fire department to give the report she had asked for at previous meetings. Mayor Ken Voigt reluctantly allowed a representative of the fire department to speak before the vote.

The Jones proposal had been to reinstate the duty crews immediately, to hire Greg Flynn as an advisor for three months, and a possible extension of how far away duty crew members could live. He also recommended that police chief Kris Faull continue as interim public safety director, which includes police and fire.

Fire fighter Alice Reed stepped forward with a lengthy report on the suggestions the fire fighters had put together for the council, as requested by Bates.

At the end of the report, she said the recommendations of the fire fighters was to promote Chief 2 Chris Zweng to Chief 1; promote Lt. Landskroener to captain; appoint two lieutenants, put duty crews back in service at two days a week now, growing to three, to five, to seven; establish an evening duty shift; a quarterly bonus for fire fighters; sign-on bonuses and years-of-service awards; create a senior firefighter position for mid-level advancement; and quarterly meetings with members of the city council to find out what the council is thinking about the fire service.

# VBT planners postpone action on extension of 21-year-old site plan

River Park II Condos had its site plan approved in 2004 and then was not built. The roads and utilities are in place, but no condos.

At the Nov. 12 meeting of the Van Buren Township Planning Commission, Michael

Furnari of Tiburon Holdings was present with a request to build the condos now. After much discussion, the commission postponed a vote on the matter in order to get legal advice and other information on whether it could be built under the 2004 ordinances since much more is required for

Zweng rose at the end to explain only two fire fighters live in the city and that Reed's report was done in collaboration with all the fire fighters. He said a week ago, at a special workshop, fire fighters were asked to put together a report by that Wednesday and they had it by Wednesday. He said some of the information was not available to them, however.

"We're not in it for the money," Zweng said. "We're in it to protect your community ... Let us do this."

Mayor Voigt called out, "Stop!" to Zweng.

The mayor said the council appreciates the report and there were many good ideas. He said everything had been rehashed, referring to the lengthy discussion at a previous council meeting, followed by a special workshop on the department.

Voigt said the city has come up with the money to reinstate a duty crew and a quarterly progress report is a good idea.

But he insisted they need to have someone come in and help the city and they can't just do it the way it's always been done, referring to taking the next in line for chief.

"It has to be a process," he said. "Not the way it's been done in the past. We're looking for best practices."

Councilman Jeremiah Beebe spoke about grants and asked whether the city's grant writer looked for grants for the fire department. Jones replied, "Not really."

Beebe also said he was under the impression the advisor would be present at that meeting. He said any time you're asking for money for a person, that person should be present. He referred to the "hiring freeze" referenced by fire fighters, and that Jones had said wasn't really a "hiring freeze." The fire fighters had said there are three in line waiting to be hired and Jones said they could process them.

It was pointed out that the proposed advisor had been before the council when he gave the original report on the fire

Mayor Voigt said they don't really need to vote on reinstating the duty crew, since that can be done administratively. And, he said, Faull already is serving as interim public safety director.

So, the motion to hire the advisor for three months, with the possibility of extension, was made by Beebe and seconded by councilman Randy Priest. Voting yes were Beebe, Priest, Voigt, and councilwoman Julie Kissel. Voting no was Bates.

At the end of the meeting, Bates said she would make sure the new advisor had a copy of the fire fighters' report so he could put it next to the report he had given to the city, so the two proposals are "married."

Kissel said the advisor would be on duty

as of Dec. 1 and, "There's nothing like this in the archives. A first!"

Beebe said he voted for the advisor because he was tired of going around and around. He apologized to the fire fighters and said the city shouldn't hurry to put the duty crew back in because it could just end up with the problems they have now.

In other business at Monday's one-and-ahalf-hour meeting, the council:

- Heard interim public safety director/ chief Faull announce that fire fighter Isabella Teachout learned she had passed her final test and now is an EMT. Faull also said Belleville will be taking part in the shop with a cop the week of Dec. 16 and, while Meijer and Walmart donate to the project every year, this year the city school resource officer got another \$2,400 from Walmart and \$2,500 from J&T Crova
- Approved the Holiday Train Viewing party at 149 South St. this Saturday, Nov. 22. There will be commissary businesses and a lot of food while people wait for the decorated train to go past on the tracks;
- Heard Bates tell the details of this year's holiday lights contest. She said council

members will travel around separate areas of the city to judge the best lights on Dec. 5-7 and report winners to the Independent on Dec. 8, so pictures can be taken. Awards will be given to winners at the Dec. 15 council meeting. Categories will be Harbour Pointe, Victoria Commons, mobile home parks, downtown, and remainder of the city;

- Heard Stephanie Osborn of Giffels and Webster consultants ask for suggestions on the Parks and Recreation Master Plan she had presented to the planning commission the previous week and to the council that evening. Kissel suggested changes. Osborn said the plan will go out by Dec. 6 to surrounding communities for 30-day review period and then be back to the city council in January for adoption so it can get to the DNR by Feb. 1;
- · Voted to make new DPW director Nathaniel Johnson the city's official representative to the Downriver Utilities Wastewater Authority. Johnson gave a report on the last DUWA meeting. He reported an announced 3.5% increase in cost to the 13 different communities who are part of the DUWA;

- Discussed voting on the mayor-pro-tem position, since this was the first meeting after the council election and the charter said that's when a vote should be taken. When clerk/treasurer Briana Papin said she was unsure about putting something new on the agenda after it had been approved, the mayor said this could be voted on at the first meeting in December;
- · Heard councilman Priest say he finally went over to look at the new city hall and he thinks the meeting room should have the council table on a riser so everyone can see them and they can better see the public. He also commended the fire department; and
- Heard mayor Voigt say he had attended the successful Van Buren Public School Foundation fundraiser at the BYC, the SEMCOG general assembly, and the veterans' event at the high school that was not as well attended as it should be. He said councilman Priest's idea to have a slightly raised council table in the new city hall is not what is planned. The "big room" will not be set up just for council meetings and will be used like the Cozaad room at the library.

## **EXTRA THINGS I KNOW**

Two of our original investors in the Independent died last week. Beverly Yurchak died on Nov. 13 and Allen Sacco died on Nov. 15. Allen's obituary is in today's paper and Bev's obituary will run next week.

They were among the dozen who chipped in \$1,000 each to start a new local paper. They did this in December 1994 and the Independent was published for the first time on Jan. 5, 1995 and has continued ever since. Over the years various owners of the LLC have changed, but Bev and Allen were among those who stayed and supported us always. We mourn their passing.

On our police dispatch log for Belleville this week we noticed a "bomb threat" entry on Main Street at 11:12 a.m. Saturday, Nov. 15. We asked police chief Kris Faull about it before Monday's city council meeting and she explained that the call came from the museum. building permits now.

The site is located on the south side of Ecorse Road between Morton Taylor and Haggerty roads. The development was partially constructed around 2004. The request is to build 74 condos on the unused seven acres, as approved by the township 21 years ago.

Furnari has asked for an extension of the old site plan.

Township planning consultant Vidya Krishnan of McKenna Associates recommended approval of the extension, although a residential site plan is good for one year and then can be extended for one or two more years at the most. She said condo site plans don't expire. She said the property was split from the developed part and there is a question about the Homeowners Association being separate or not.

Commission vice-chairman Jeff Jahr questioned whether the commission had the legal authority to grant this extension. He asked for a letter of reapproval from Wayne County for the drainage. He said the parcel would not be able to be developed under the new ordinances.

Commission chairman Brian Cullin said he would like to see continuity in the development from the old to the new.

Furnari said he would like to start building in the spring. He said he has been

paying property taxes on the 74 parcels and, "I just want to develop my lots."

"I've never seen this before," Jahr said. "We have some concerns ... On the surface it's not a bad idea."

The commission unanimously passed a motion to postpone action until they get a letter from Wayne County on water detention, have the staff consult with the township attorney, look into the possibility of putting the parcels back together, and see a comparison of regulations from 2004 compared to those in effect now.

In other business at the two-hour-and-37-minute meeting, the commission:


- Postponed action on a request by Davenport Brothers on behalf of owner Sdukhdev Singh of Chahal Trucking to amend the approved site plan for a repair facility. More information is needed and there was no one present from the applicant to respond to questions;
- Approved a site plan for a dock and stairs for Mission Pointe on the Lake Subdivision Association at 13085 Ventura Dr. Structural steel will replace the 20-year-old wooden structures that have deteriorated. There will also be 10 steel pilings. No slips will be rented and this will be just for daily recreational use, according to the association representative;
- Discussed the proposed drafts for the MRD (Mixed Residential District) and MROD (Mixed Residential Overlay District) and set a public hearing for Jan. 14 on the ordinances;

• Discussed proposed ordinance amendments to control the placement of car washes. A moratorium on car washes is in place until April 7, 2026, but a new car wash has been proposed on Belleville Road and is under staff review. Krishnan said with the Water Works and new Zippy Car Wash on Belleville Road and the application by El Car Wash in the same area, that will make three car washes within one mile of each other. She noted Zax Car Wash in the city of Belleville is within a mile of Zippy, making four in that area; and

• Heard Krishnan say that she would like to see traffic impact studies to be conducted by the township engineers instead of the applicant's engineer, the way it is now. She said she has never seen an applicant's study saying something wasn't feasible. Jahr added that there are no consequences if the study is wrong. Krishnan wants to put this in the car wash ordinance being proposed.







cost of \$321,484 from the bond money for pre-construction services for each phase over the next six years, plus 2.0% of the project for work as it progresses. Project manager is Bryan Darling. Kakocski said it will be six to 10 months before starting the first project.

Kakoczki also had presented information on architectural and engineering contracts recommended. Out of seven firms bidding, The Collaborative+Acock was recommended at a lump sum fee of \$3,249,481 and reimbursable costs of \$150,000. He said this information is to "get a jump start with the first projects" after the election approves the bond.

In other business, the board:

- Heard fall building presentations from the staffs of Rawsonville and Tyler elementary schools and the Early Childhood Development Center;
- Approved hiring Curtissa Frison as a fifth-grade teacher at Owen Intermediate School and Jennifer Frazier as a resource room teacher at McBride Middle School, both starting Nov. 17;
- Approved the retirement of William Frazier, a paraprofessional at Rawsonville Elementary School, as of June 30, 2026, after 38 years of service; and the resignation of administrative assistant Journana Kadri, who worked at the administration building, as of Nov. 11 after three years of service; and
- Went into closed session "to consider material exempt from discussion or disclosure by state or federal statue" and came back into regular session only to adjourn.



## Belleville DDA holds special meeting to discuss Hayward's grant

A special meeting of the Belleville Downtown Development Authority was called for Nov. 5 to discuss upgrades to Hayward's Liquor Store at 573 Main St. Business owner Jennifer Kouza is applying for one of the \$20,000 grants the DDA offers for façade work on businesses in the district.

No decisions could be made at the meeting because five of the nine DDA members could not attend the hastily called special session. No votes can be taken without a quorum. Present were chairman John Winter, vicechairman Chris Donley, treasurer Sabrina Richardson-Williams, and mayor Ken Voigt.

At the DDA's Oct. 15 regular meeting, Kouza was not present but DDA manager Steve Jones said she wanted to do exterior facade improvements, including the roof, shingles, corner repair, and sign replacement. Jones said someone damaged the corner of her building and also the sign had been knocked down. He said the DDA's grant program allows up to a \$10,000 grant and up to a \$10,000, three-year no-interest loan.

More information was needed and so the grant was put off until the Nov. 5 special meeting when Kouza could attend.

Kouza brought Rad Greaves of Radford's construction to the meeting with her and he said he had been a friend of her late husband and wanted to donate some of the project to

He said after he tears the roof off, he will see if the building can support the weight of slate tiles he plans to donate and that would take copperwork as well. He said he planned a batten look to the building that was commercial and not too homey.

Kouza said the wood is old and it's been at least 40 years since upgrades were made.

Greaves said it's been cedar shake since

Kouza said she sees former owner Roy Acho once in a while and he told her the façade hasn't been touched since his day.

Mayor Voigt said he remembers when he was 12 years old and his father brought him to Hayward's. They had soft-serve ice cream at the time.

Jones said the upgrades to the building will keep it with the same shapes.

Kouza said she's been trying to do things over the five years since her husband died, "God bless my husband." He had owned the business for 30 years. She said there's more to be done on the dock.

DDA chairman Winter said she has tried to improve the business.

Kouza said the state shut the business down over a gas leak that had to be repaired. She said she is so much caught up on the lower level, with wood rotting, and people stealing

She said she plans a simple, basic color.

Winter said the colors are up to her and the city can't tell her what colors to use.

Jones said she could paint several swaths of different colors on the building and have the people weigh in.

Kouza said she wants respectable colors, adding the dock has to be painted as well.

Greaves said the business seems historical to him, since he was friends with Kouza's husband. He said he did Mama Mia's restaurant on Mackinac Island, as a reference to his experience.

"We're the face of the city," Kouza said, noting Hayward's is one of the things drivers see first as they enter Belleville. She said on Halloween some people told her they were sorry the cross came down. She said she told them Hayward's is a liquor store, not a church, and they seemed satisfied with that

Greaves said he thought a nautical theme would be good.

DDA vice chairman Chris Donley agreed that sounded good because they were on the

Kouza said the lottery representatives say Hayward's numbers have been way up, so business is good.

Mayor Voigt said the DDA could approve the grant at the regular meeting in two weeks when there is a quorum and those present that evening will recommend approval.

"But, it's not approved until it's approved,"

"I was glad when the request for the grant came in," said DDA treasurer Richardson-Williams, adding she appreciates Kouza wanting to fix up the place.

Kouza said she didn't own the building or property, but she does own the business. She said the owner told her she could do what she wanted with the building and she wants to be "uplifting the store."

Mayor Voigt said Kouza also plans improvements to the old ice house, which now holds propane.

Kouza said they will meet the ordinance on sign regulations and she plans nothing electrical on the sign.

Greaves said when he gets into the roof he can relocate the electricity, if necessary.

Donley questioned whether Kouza was going to paint the red brick to tie in with the nautical theme. She said the orange brick was painted and is chipping so she is not so sure about painting brick.

Kouza asked about the timing and if she had to be done by a certain date and she was told there was no time limit. Greaves asked if he could work at night and Mayor Voigt said he could as long as he doesn't disturb nearby residents. The city has a noise ordinance, mayor Voigt said.

In other business at the 28-minute gathering, Donley asked about power to light a Christmas tree on the flagpole at Five Points and was told the power there belongs to the county. He then suggested that a Christmas tree could be put up in the shopping center at the entry to the city. "I'll talk to him," Donley said, referring to Scott Jones who owns the shopping center.

## Keystone Academy charter school student absentee rate drops to 8%

Keystone Academy principal Jorvonna Drain reported as of the school's board of directors' meeting on Nov. 13, the student absentee rate had just dropped to 8%.

That was down from the previous month, she said.

The staff had been making an effort to reduce the absentee rate so the students will be in class to learn and it is working well, Drain said.

Absentee rates in surrounding school districts are much higher, the board noted.

Board president Chris Mihaly said the comparison of students enrolled from three years ago is higher and she complimented Drain and her teachers. She called the growth "impressive." The enrollment was 696 in 2023-24, to 718 in 2024-25, and 731 in 2025-26.

When asked about grade 4 and its smaller number of students than other grades, Drain said that was the COVID group of students and some of them in that group never even started school.

Board vice president Steve Harsant said the public should hear about the high grades at Keystone and Keystone should advertise on television like another charter school is doing.

National Heritage Academy representative Andrew Roth said NHA decides which schools to advertise. Drain said she could mention to them that Keystone would like to be considered.

It was noted 57% of Keystone students reside in the Van Buren Public Schools district, 23% live in the Lincoln Consolidated School District, 5% in Romulus Community Schools District, 4% in Wayne-Westland Community Schools District, and 3% in the Huron School

District.

In other business at the Nov. 13 meeting, the board:

- Heard Rahki Kapoor from Alan C. Young and Associates give the audit report for the fiscal year ending June 30, 2025, noting Keystone received an unmodified opinion, the highest. She said the fund balance was \$69,899 and enrollment was up for the past two years bringing in more state money. The revenue grew from \$8.2 million to \$8.8 million. The clerical error of \$71,668 reported did not affect the audit report and was corrected, she said. Her report was done by zoom, with her face projected on the wall;
- Approved the 2025-26 amended budget;
- Approved a request to purchase additional electric tuners for the concert band at a cost of \$315. Band director Joshua Bialochowski said this investment will directly benefit the students and enhance the quality of the band program;
- Approved giving Amazon gift cards to the staff for this year's holiday present from the board;
- Heard Drain report that the school acknowledged more than 40 veterans from the Keystone community at it annual Veterans Day assembly. A Veterans Wall was put together providing a display of all the veterans from the Keystone community, even those who couldn't make it to the assembly. The PTO organized the reception, families donated items for the reception, and students spent time as volunteers, giving up their time at lunch/recess to help;
- Learned Keystone has hired an occupational therapist and extended an offer for a speech therapist, with the

resource room teacher's medical leave to end at the end of the year. The social worker position is still open; and

• Was advised the book fair is Nov. 24-25, classes will be dismissed at 11:20 a.m. on Nov. 25 and will be closed for

Thanksgiving until Monday, Dec. 1. A holiday food drive is Dec. 1-5, a band concert at 6 p.m. Dec. 6, and the Harper Mathis Toy Drive on Dec. 15. Winter break is Dec. 22-Jan. 2.


