# Lionel Vincent found guilty of murdering VBT mother, daughter

A Wayne County Circuit Court jury found Lionel Lamont Vincent, 52, guilty of one count of first-degree, premeditated murder and not guilty of a second count of first-degree murder. Instead, he was found guilty of a second, lesser count of seconddegree murder. The jury trial lasted two weeks. Sentencing is this week.

He originally had been charged with two counts of first-degree murder. He was on

trial for stabbing to death a mother and her 14-year-old daughter in Van Buren Township on July 25, 2021. At trial it was revealed there were more than 15 stab wounds on each

Yachanda Snipes, 45, who had dated

Vincent, and her daughter Daraca Leatherberry were found dead inside their apartment in the 46000 block of Lake Villa Drive within the Belleville Pointe apartment complex.

The jury verdict was announced on Oct. 31. Sentencing is Nov. 24.

Vincent was brought from Lakeland Correctional Facility in Ionia by the Michigan Department of Corrections

for his preliminary exam at 34th District Court in June 2022. He was being held on pending charges of violation of probation on a previous charge.

Now retired Van Buren Township Police Detective Mike Long said at the time that Vincent was the suspect from the beginning and the victim was an Uber driver at the time they met. Det. Long said the state

# Celebrating 100-year-old Sophie Zoller, parade Grand Marshal

One of this year's Winterfest Parade Grand Marshals is Sophie Zoller, who has not only lived through a century of change, but helped shape decades of Belleville's story. Turning 100 years old this year, Sophie remains an active, joyful, and beloved member of the community.

Sophie and her late husband, Harry Zoller, moved to Belleville nearly seven decades ago in 1957. "We wanted to live in the country," she recalled. "Harry had started working at the Ford Rawsonville Plant and Belleville seemed like the perfect place to build our life."

Over the years, they did just that -raising a family, making lifelong friends, and pouring themselves into the heart of the community. Today, Sophie's legacy continues through her four grandchildren and three great-grandchildren, who carry forward the same love for Belleville that she and Harry shared.

If there's been a Belleville event, organization, or club over the past several decades, chances are Sophie has been a part of it. Her resume of community service reads like a history of Belleville:

- Longtime member of the Business and Professional Women's Club, later the Belleville Area Women's Club, and now the Ladies of the Lake, where she still attends monthly dinners.
- Deeply involved in St. Anthony's Parish as a room mom, member of the Mother's Club, and later a Parish Council member and committee volunteer.
- Helped create the Belleville Centennial Quilt, now proudly displayed at the Belleville Area District Library.

- A major force behind the first Strawberry Festivals, chairing booths and leading volunteers at St. Anthony's, especially her famous pie booth, which she ran for years.
- Held leadership roles in the Belleville Moose Lodge and Women's Auxiliary of VFW Post 4434, serving as president and officer in both.
- Founding member of the BBC Striders walking and running club.
- Worked as an election official and precinct chairperson for many years.
- Active participant in local bowling and golf leagues, including at Lodge Lanes and Pine Creek Golf Course through the Senior Center.
- Member of several quilting groups throughout the region.

When asked what inspired her to stay so involved, Sophie's answer is simple and heartfelt: "I love living here. It's important to be a part of the community you live in, to give back and make it even better."

For Sophie, Belleville's charm has always been its people and its small-town warmth. "Friends, the country setting, the small-town feel, that's what makes Belleville home," she said. "It's the sense of community you can't get in a big city. Everyone knows someone, and everyone looks out for each other."

Her favorite memories reflect that spirit, from marching in the Christmas and Strawberry Festival parades with the VFW and Women's Club, to walking the Mackinac Bridge 19 times. She fondly remembers the Taste of Belleville, especially walking the bridge as part of the celebration. "I've always enjoyed being part of the action," she said.

Of all Belleville's beloved festivals, the Strawberry Festival holds a special place in Sophie's heart. "When it first started, it was a chance to show off our community and celebrate together," she said. "Now I also love the Harvest Fest in October, it still brings people together in that same spirit."

Sophie has also been a familiar face at Winterfest over the years, often decorating her car and joining the parade. "Throwing candy and seeing the children's faces always made me smile," she said. "It's just so much fun to be part of something bigger."

When Sophie reflects on her life in Belleville, her pride shines through. "I'm proud of many things," she said, "but especially running the elections and being involved in so many community activities. I just love Belleville. I couldn't imagine living anywhere else."

When she learned she had been selected as a Grand Marshal for the 2025 Winterfest

Parade, Sophie was overwhelmed with joy.

"Excited!! I felt so honored. I couldn't believe I was chosen. It's such a great honor, and I'm so looking forward to it."

Even at 100 Sophie's vision for

Even at 100, Sophie's vision for Belleville's future is vibrant and forward-thinking. "I hope our community continues to grow," she said. "It would be wonderful to see a theater, and more restaurants but still keep the small-town charm intact. We have such a wonderful community."

And her message for the season is as timeless as her spirit:

"Merry Christmas! I hope our community will always stay friendly and open to newcomers. Without them, we don't grow in spirit and love. I hope Belleville continues to be the amazing place it is today. I love this town."

Sophie still enjoys visiting her favorite local spots: Garden Fantasy on Main for flowers, Victory Park for memories with her grandchildren, The Bait Shop for shrimp and fish, Johnny's on the Lake and Egan's for a great burger. "Pretty much anywhere in Belleville is wonderful," she said. "It's such a unique and special town."

Sophie grew up on a potato farm in Posen, MI, and came to Detroit in 1947 to work at Timken Axle, all on her own. "I was a farmer's daughter who didn't even know how to drive when I moved to Detroit," she said. "But I figured it out!"

Sophie said the spirit of Winterfest reflects everything she's loved about Belleville for the past seven decades: "It's about people coming together to celebrate our town. It's such a happy time to be in Belleville. I'm just so proud to be part of this community."

# Pastor Bob and Becky White named parade Grand Marshals

This year, the Belleville Area Chamber of Commerce honors Pastor Bob and Becky White from Grace Baptist Church as Grand Marshals of the 2025 Winterfest Parade, a tribute to two lifelong residents whose dedication, kindness, and faith have helped shape the heart of the community.

For Pastor Bob and Becky White, Belleville isn't just where they live, it's where their story began. "Becky and I have lived most of our lives in Belleville," Pastor Bob said. "We both attended elementary school and South Junior High, where we met in the seventh grade -- the very first year the school opened. We graduated from Belleville High School in 1970."

Their families first came to the area in the early 1950s, when Bob's father, Jim, began working for Eastern Airlines. Decades later, Belleville remains not just their home, but the place where generations of their family continue to grow and thrive. Their three daughters Rachael, Natalie, and

the late Emily and grandchildren, Evelynn and Madelynn, all called Belleville home as well.

As the longtime pastor of Grace Baptist Church, Pastor Bob has spent decades serving the people of Belleville both spiritually and personally. His involvement spans countless community efforts, including the Van Buren Health Advisory Committee, V.F.W. Memorial Day and Veterans Day services for more than 30 years, and the Brown Funeral Home "Tree of Remembrance" program.

Behind the scenes, he's been a steady hand in many of Belleville's special events often helping quietly, without seeking recognition. "Since Belleville is our hometown, I want to see it thrive," he said. "We love our community and want to help in any way we can."

When asked what makes Belleville feel like home, Pastor Bob's replies easily. "It's been home for over 60 years. Our family

grew up here. I know many of the older residents, and it's always good to reminisce about the past."

Among his fondest memories are being part of the Veterans Memorial dedication ceremonies, celebrating Grace Baptist's 50th and 75th anniversaries, and reconnecting with a mentor -- James Richendollar, a beloved Belleville coach, teacher, principal, and superintendent of schools who helped shape his early path toward education and ministry.

For the White family, Belleville's greatest treasure is its people. "It's that small-town feel," Pastor Bob said. "People here share a common goal, helping each other through difficult times and working together for growth."

That spirit shines brightly during community traditions like Memorial Day, Veterans Day, and of course, Winterfest. "I always enjoy the Christmas season," he said. "People seem happier, more generous. There's something special about how the spirit of giving comes alive."

For Pastor Bob and Becky, Winterfest is more than just a celebration, it's a reflection of what truly matters. "As we gather for this most wonderful time of the year, I

The Winter Fest fireworks on Dec. 6 at the west end of the Denton Road Bridge scheduled for from 6:30 to 7:30 p.m., will actually begin later than what was approved by the Van Buren Township Board of Trustees on Nov. 18.

The Angel of Hope ceremony, that is on Dec. 6 every year across the county, this year is during Winter Fest and it starts at 7 p.m. The Angel of Hope event is at Hillside Cemetery right next to where the fireworks are being staged, so the fireworks are going to be delayed. They were thinking 8 p.m. or so. Don't give up on the fireworks.



# VBT approves DDA amendment, Morton Taylor paving project

After a public hearing on Nov. 18, the Van Buren Township Board of Trustees unanimously adopted the Third Amendment to the Development and Tax Increment Finance Plan for the VBT Downtown Development Authority. This is the first reading of the ordinance, with the second reading and final approval to be at the Dec. 2 meeting of the township board.

DDA director Merrie Coburn explained that the township's DDA was established in 1990 and the development plan was approved and expires in 2038. This is the third refreshing of the plan since 1990. The last amendment was in 2009. The district has remained the same size and there is no plan to change its size.

"The district has had a lot of growth since 2009 and the third amendment will reflect that with added projects and costs, revised cost estimates of projects that have not been completed to reflect the rise in costs, updated maps and updated tax capture revenue spreadsheets," she said.

Coburn presented a list of high-priority projects, with the Belleville Road widening at the top, sidewalk and nonmotorized improvements and maintenance, Belleville Road improvements from I-94 to Tyler, Belleville Road streetlights from Tyler

to Ecorse, and concrete joint repairs on Belleville Road. Other projects were listed as medium and low priority, along with ongoing annual projects.

She said that there are 1,161 residents in the DDA district and Public Act 57 requires a citizens' council of seven to be formed if there are more than 100 residents in the district. The council is made up of those residents or those closeby the district, so the council was formed. It has met three times to consider the amendment.

During the public hearing, Reg Ion said he would like to have a hard copy of the amendments. He said there was a lot of money spent on the landscaping at Ecorse and Belleville roads but the snowfence that used to be between Ecorse Road and the South Service Drive is gone. He said when they plow Ecorse, now the snow goes onto the Service Drive where he lives and he has to plow it out. He also said there is no longer grass cutting along the Service Drive. He said they should spend more money on the residents in the township, instead of on businesses. He said the airport bought the Saratoga property on Ecorse and is now offering it for development. He said he is not in favor of the Stellantis development now under way on Ecorse.

Another speaker, who said he lives on (continued on page 13)

Morton Taylor and the North I-94 Service Drive, asked about paving Morton Taylor Road, which was on the agenda. Supervisor Kevin McNamara said the township wants to pave Morton Taylor Road north of Tyler Road, but not in his area yet. He said the township had an agreement with a developer to pave that part of Morton Taylor, but the township got money from Wayne County to split the cost. McNamara said VBT residents have the lowest taxes in Wayne County.

In other business in the 68-minute

meeting, the board:

- Approved adjusting a 2025 road paving budget item from \$0 to \$850,000 for the first payment for the Morton Taylor Paving Project to pave Morton Taylor between Tyler and Ecorse. McNamara said the cost is being shared with Wayne County and, "That's how we got Haggerty Road." The total cost is expected to be \$3.5 million and the township will pay up to \$1.7 million and the county will pay anything over. The township will pay \$850,000 in 2025 and \$850,000 in 2026. He said the township is asking the residential developer on the northwest corner of Tyler and Morton Taylor to kick in a couple of \$100,000s;
- Approved a fireworks display permit application from the Belleville Yacht Club for Michigan Fireworks Club on Saturday, Dec. 6, with a rain date of Sunday, Dec. 7. It will be staged on Denton Road just west of the Denton Road bridge, the place it had been staged over the past three years. This event is part of Winter Fest;
- Witnessed a presentation on the design plan developed by contractor PEA Group for the front entrance area of Van Buren Park. Trees are being cleared next to the sled hill and along the South Service Drive. A bunny hill will be put in next to sled hill for young children. A new community garden area is planned to the west of the drive with a 23-car parking lot, pavilion, and tool shed. There will be a fence and piers along the drive, along with a fitness area, no-go zones for wildlife, a gate to the maintenance area, native plantings, and other park amenities. McNamara said none of this is budgeted, but if you don't have a plan, no one will give you money. "We're reloading the barrel to go after some more money," he said, noting a long list of grants

received by getting a plan first;

- Heard clerk Leon Wright state that the township hasn't raised taxes at least since 2008 when he first got here. He also said the township had about \$50,000 in health care cost savings over six months by utilizing EHIM's model based on employee usage instead of a standard 20% cost to employees;
- Heard a resident of Crowley Road ask about the drift race track on Robson Road. McNamara said it's in court now and the race track owner is fighting it. He said the case is expected to move forward in the next year since this is the busy holiday season; and

· Heard resident Reg Ion say there has been a lack of maintenance at Van Buren Park and the trees and shrubs having to be cut back are because of ten years of neglect. He said the American flag at the park was on the ground and he reported it, but doesn't know if it's been picked up. "I have yet to see a damn bicycle on the Iron Belle Trail," he said. He said the water tower should have been built in Van Buren Park. He suggested they start testing the water and soil at the park. McNamara said it's been tested and it's good. He said he's concerned about the flag comment, also noting the grant money is not tax money. Ion replied, "It's still my tax money."

# Belleville DDA forms committee to make progress on projects

A committee was set up of Belleville Downtown Development Authority members at their Nov. 19 meeting to make progress on the hardware store at 458 Main St. that it purchased in October 2023 along with the property it purchased at Third and Main at the same time.

Volunteering for that committee were Phil Miller, Mike Gatteri, and Sabrina Richardson-Williams. President of the Belleville Area Chamber of Commerce Dinara Strikis asked if a member of the public could join in and she was placed on the committee, as well.

Steve Jones, DDA Coordinator/interim city manager, had put several items on the agenda concerning the former hardware store that he has named the "WhereHouse Project." He had proposals for new art on the windows, finishing construction, flooring, and interior paint.

The DDA approved Jones' request to spend \$1,000 to have an artist scrape off the old paintings on the WhereHouse windows and replace that with winter scenes by the same person who did the windows at the Rustic Crow. When pressed, he said the artist who will get \$1,000 for the work is Gerina Rohman.

On July 17, 2024 the DDA voted to pay another artist \$3,000 to paint the present

pictures on the windows. On Feb. 19, 2025, the DDA approved \$44,480 to fix a wall at the hardware store.

Jones also suggested some kind of sealing for the floor that is bare now that the old tiles have been torn out. And, he said, the bathroom project has to be done. He said he could get two carpet square quotes for the next meeting, and they will be between \$25,000 and \$30,000. Or they could go with cleaning the floor and painting it for about \$2,500 or grinding it and putting on clear epoxy for \$1,500.

Miller said they would need quotes from more than one vendor.

DDA member Donley said they don't know how the space is going to be divided. He said they shouldn't spend money on painting "until we know where we're going."

"I agree," Jones said. "Make it adaptable at the lowest cost so it looks finished enough."

DDA member Miller asked what the timeline is for completing the hardware store upgrade and Jones said, "As soon as possible."

DDA member Beaubien asked, "What is our vision?"

Board chairman John Winter said the plan was for pop-up shops.

"I thought by Christmas we'd have





some popup shops," said treasurer Sabrina Richardson-Williams.

Jones said with the change in management at the city, he has had longer days, referring to not having enough time to do everything.

Donley said the DDA has people to sign up for tasks and have time to do it.

DDA member Mike Gatteri said they could send out a group email to ask for help. He said they need a clearly defined timeline and a committee could do that. Otherwise, it kind of gets pushed under the

Jones said he put the name "WhereHouse" to signify "where you come to start your business." He said some community groups asked if they could have space to hold meetings there.

Donley said the building is still for sale so there are several options on the table.

Miller said a commercial project wants a white box. He said the committee can look at the longterm strategies and midterm strategies. Have an incubator up and running for 18 months to see how it goes. They could look into a four or five-year plan.

Jones said he got an email from the county about granting money for industry, such as micro manufacturing, metal work, businesses and he will look into that.

Donley said to share that with the committee.

Miller agreed and said they'll get the committee together and set up a plan. He said he recently became a real estate agent and that has other information available.

Winter said the report from the committee will be put on the January agenda.

In other business at the one-hour-19minute meeting on Nov. 19, the DDA:

• Approved a \$20,000 façade grant for Hayward's Liquor Store, 573 Main St. The work had been discussed at a recent DDA meeting that was held without a quorum. Jennifer Kouza, business owner, and Rad Greaves, contractor, told of their plans to upgrade the building that was built in 1932 or 1934. Greaves won't know what roofing will be put on until he opens up the roof and see how much weight it can carry. He would like to use slate tiles that he has on

hand and would donate to her project, but they are heavy. They were asked to keep the city informed on what is decided. Kouza said the work has to be done by March when the number of customers increases;

- · Learned Beaubien had gone door-todoor along Main Street and from 12 to 15 businesses had signed up for a \$1,000 grant each for Christmas lights. She reported that since the grant can only be used to purchase lights and related items and not for labor to put them up, each will get less than the \$1,000 allocated, so there will still be money left in the allocation. They voted to uncap the maximum number of businesses in the program because there is money left;
- Heard Gatteri, who suggested the grants for lights, say since there is money left, they can use some of the grant funds for the hardware store holiday lights, draping red and green lights from floor to ceiling. Miller said they shouldn't use grant money for the hardware store and Jones said they could pay for it otherwise; and
- Heard secretary Denise Baker say she had a problem with the finance report because items are not posted properly and everything is lumped together. She said she will work with Jones and the staff to get it posted right. Miller asked for a trial balance and Jones didn't know about that and said he would find out. Miller suggested using POs, but Baker said an invoice number goes to the account and a PO is another step. Jones said he will work on this.

and excused from the meeting.

The commission also unanimously approved special land use for Sumpter Properties, LLC, a used-car lot at 25891 Sumpter Rd., which had been requested by Nassar, who now is pulling out of that business to go to his new business on Savage Road. The new owner of the Sumpter Road property is pursuing the legal approval of that lot.

The commission also unanimously approved the site plan for 25891 Sumpter Rd., which had been requested a year ago. Neighbors say he has been operating without the legal approval for all that time, bringing in cars and, at one point, stacking them up in the back of the property.

In other business at the two-hour-and-20minute meeting, the commission:

- Discussed draft ordinance language for the Wetland Mitigation Bank. The language is not complete. Township trustee Matthew Oddy explained that EGLE (the state's department of Environment, Great Lakes, and Energy) had approved a wetland mitigation project behind a mobile home park on Willis and put it in without notice to the park. He said the township has lots of wetlands and Crosswinds Marsh is the largest wetlands park in the state. He said the township doesn't want good farmlands to be put into wetlands. Wetland banks are where wetlands are legally transferred from areas that don't want wetlands;
- Discussed and then approved revisions to the Solar Ordinance;
- Approved the meeting dates scheduled for 2026;
- Tabled until the Jan. 8 meeting a request for special land use for a veterinary surgery suite at 40030 Willis Rd. because the applicant was not present. This had been discussed at length at a previous meeting. Commissioner Nicole VanAssche said she has been thinking about it and the township should encourage businesses in homes. She said maybe it could be open one day a week;
- Removed from the agenda without comment a request for rezoning of five parcels from MHP to RF or R1; and
- Discussed an Augusta Township man's plan for his newly purchased property on the southwest corner of Willis and Sumpter roads. He said he has upgraded the inside of the former Art's Appliance for a business and wanted guidance on how to use the former car repair shop on the corner. He said he is considering a custom welding shop or auto detailing by appointment. Trustee Oddy suggested he come in and talk with Joe Pezzotti, the township's planner, to get an idea of what would work with the zoning. The man said he did that a couple of times and said Pezzotti said to come to the commission. He was told to work with the planner to come up with

at the beginning of the meeting started with engineer Justin Novak of Wyandotte, Nassar's consultant, explain that Nassar wants to do outdoor auto repair, add a greenbelt, and put in a privacy fence.

Township planning consultant Pezzotti in his report on the request said this business has been an auto repair shop for some time. It has commercial zoning to the north with outdoor storage, no major site changes, and two entrances on Savage Road. The required trash containers are not shown on his site plan and must be added, he said.

He said 30 parking spaces are required and they are shown on the plan as places for cars for sale. The township also needs to see the required 10% landscaping on the plans.

He recommended that the commission send the special land use approval to the township board for final approval, with stipulations that there would be no outdoor storage of discarded parts and Wayne County would approve the plan.

Judy Graves of 17600 Savage Rd., just south of the site in question, said her home was built in 1861 and is one of the original buildings in Sumpter. It was the original

stagecoach stop in Sumpter Township. After she and her husband bought the property, they carefully maintained it.

She said the used cars parked right along their property line makes the aesthetic value of the property go way down. She said before the new use, it was a repair

shop that was family owned and that family cared about this community. They didn't leave cars overnight in front of their building and put them behind the fence for the night.

"It breaks my heart," she said, noting their property value will go "down the toilet."

The business' hours will be 9 to 5, but it's a residential area and people get off work at 5 p.m. and go looking for cars,

she said. She said Nassar said there will be no additional lighting and that is good. But having the cars in front isn't good. The way the late Jim Hughes did it with putting them behind the gate "was lovely."

She said, "I don't want that next to my house." She said Hughes told her he would put in a privacy fence, but he died before he could do that. "I love the Hughes family."

Next speaker was Cheryl Norden, from

The Bake Shoppe, just to the north of Nassar's new property. She had many questions. She said when she wanted to have storage on the two acres attached behind the property for her bakery, the township had turned her down. She said she had been asked how many vehicles she would have, but they have not asked that of Nassar's property.

She asked if they will be fixing cars to be sold? Are they selling parts on the open market? What about the scrap? What about a traffic-flow analysis? What if a car battery explodes? The way the cars are being delivered is not acceptable, she said. The hauler pulls up to the garage door and lays on the horn, she said. Traffic is stopped by a person on the road to get the hauler on to

She said it lowers the property values and is intrusive to the area. She said Hughes put the cars away at night. She said she doesn't want this to turn into a chop shop, like the ones at Willis and Sumpter, Rawsonville Road, and now here.

Commission chairperson Jane Stalmack asked her to stop talking and Norden refused, saying she got a letter from the township asking her to come in and give her views at the public hearing and she's giving her views. She brought along a poster with pictures of the cars at Nassar's location at his Sumpter Road location.

Next speaker was Joseph Meadows who said he lives at 17770 Savage and he is next door to what has turned into a \$2.5 million federal remediation project. The yellow tapes keep people from going on that property since it contains lead contamination from many years ago from the Huron Valley Steel plant.

He said he is a veteran and he came to Sumpter in 2012 and now there is contamination on one side and used cars on the other. He said Nassar is a nice man. Meadows said he now has turkey, deer, and raccoon in his back yard and they will be gone. The smell of burning oil is in his backyard. It's the aesthetics, he said.

Damon Schultz of Willis Road said Nassar will bring a nice, legal business to the community. He told those who complain about living next to commercial zoning that they knew that property was commercial.

Ron Watson of Riggs Road said he has known Nassar for ten years and he is part of the community. "He's going to make that business great," Watson said, adding he hopes Nassar will work on car repairs.

Steve Memering of Bemis and Willis roads said, "I back him 100%."

Christina Meadows, 17700 Savage Rd., said Nassar's business will be open from 9 to 5, but people look for cars after work and on weekends. She said there will be a lot of signage and lighting.

"I'm breathing a lot of smoke," Meadows said. "I'm hearing a lot of gunshots late at night, all days... My dogs are going crazy, my neighbor's dogs are going crazy ... It should remain residential by the park... The business is not there yet and we're seeing fights already ... People we don't know are coming in."



held Vincent for possible parole violation because of the VBT police investigation. He was wearing his GPS ankle monitor, required for his parole, at the time of the killings, police said.

According to the Michigan Department of Corrections, Vincent was paroled Sept. 22, 2020 after serving 27 years in prison for an Aug. 25, 1994 kidnapping and rape, using a weapon to commit a felony and various other weapons charges, in Oakland County. He was convicted in a jury trial.


