EGLE issues 10-year hazardous waste license to Wayne Disposal

The Michigan Department of Environment, Great Lakes, and Energy (EGLE), on Jan. 29 issued a renewed Hazardous Waste Management Facility Operating License to Wayne Disposal Inc. (WDI), following a comprehensive regulatory review and public comment process.

The license, which is in effect for 10 years from this approval, authorizes WDI to store hazardous waste in containers, expand the disposal capacity of the landfill, and continue disposing of hazardous waste, certain radiological materials and polychlorinated biphenyls (PCB), at 49350 N. I-94 Service Dr., Belleville, MI [Van Buren Township], subject to updated and strengthened conditions designed to protect the surrounding community and the environment.

This license issuance follows an extended public comment period that spanned from

Aug. 14 to Oct. 31, 2025. EGLE reviewed and considered all comments received.

Changes made to the license to address public concerns are identified in the Response to Comments.

Belleville DPW declares its salt shortage, using only at intersections

At Monday's meeting of the Belleville City Council, a resident of Victoria Commons asked what happened to the salt this year. He said the intersection was fine, but then drivers slide into the subdivision on a slight hill there.

Mayor Ken Voigt said there is a shortage of salt statewide and nobody can buy salt.

Department of Public Works director Nathaniel Johnson said in the past, the city's DPW directors had direct contracts with the Detroit Salt Company and they ended up with more than enough because the winters had been mild. There was a lot of salt left over each season.

Johnson said now they are using the Mibid governmental system. He said they have enough to handle the intersections. He said they are minimizing salt use, but make sure to do the intersections for the police and fire fighters can get to where they are going safely.

He said if it's below 20 degrees, salt doesn't work.

Johnson said they could use sand, but then they'd have to suck it out of the sewers and EGLE (Michigan Department of Environment, Great Lakes, and Energy) would get after them.

He said the plan is to plow all the streets and keep the salt for major intersections.

The resident thanked them for their explanation and then asked about the hazardous landfill trial that was coming up.

Mayor Voigt said the trial is going on this week and next and he is due to testify on Tuesday afternoon, Feb. 3, before Judge Sean Cox at circuit court in Detroit.

He said EGLE granted a new license for the expanded landfill just four days before the trial was to begin. He said now Wayne Disposal, owned by Republic Services, has the right to go 50' higher than before.

In other business at the 49-minute meeting

on Feb. 2, the council:

- Was introduced to the newest police officer, Norman Brooks, who is retired from the Westland Police Department and earlier had worked as a dispatcher in Belleville. He started work for the city on Jan. 9. His brother, Charlie, is also a Belleville police officer;

- Proclaimed April 2, 2026 as Mildred Elizabeth Baker Day in the city of Belleville on the occasion of her 100th birthday. A proclamation in her honor was read by the mayor and adopted by the council;

- Heard Jay Wilde of Alan C. Young present the city's auditor's report for the last fiscal year ending June 30, 2025, with an unmodified opinion, the highest. He said the revenue went up because of the new public safety millage. Revenue was \$4.4 million and expenditures \$3.6 million, with \$888,000 transferred out of fund balance leaving \$2.9 fund balance at the end of the year, down \$115,849 from the previous year. He reported

\$800,000 was spent to buy the new city hall and \$120,000 went to the cemetery fund. He said fund balance money also was spent on streets;

- Approved the mayor's new appointment of Alexander J. Henry to Parks and Recreation with a term to expire Dec. 31, 2029, and the reappointment of Angela Samyn to the Civil Service Commission with a term to expire Dec. 31, 2031. Mayor Voigt said the Civil Service Commission will hold its first meeting the next afternoon;

- Deferred action on clerk/treasurer Briana Papin's request to raise the rates for using Victory Station since it has been upgraded. She based rates on what it costs each on two, similar rooms at the Van Buren Township Community Center. The current Victory Station fee is \$20 per hour for residents and \$40 for non-residents. She asked for a revised fee of \$75 per hour for residents and \$100 per

hour for non-residents, or a bundled rental option of \$225 for three hours for residents and \$275 for three hours for non-residents, with up to two hours additional time for \$50 per hour. Mayor Voigt said, "Seems like a big jump";

- Removed from the agenda for the third time, without comment, an item on Tax Incentives for City Economic Development;

- Approved a resolution accepting Wayne County permits to work along county road rights of way, a yearly formality;

- Heard Public Safety Director/Police Chief Kris Faull say she will report on how the fire

department duty crews are going and the status of the search for a new fire chief at the next meeting;

- Heard interim city manager Steve Jones announce the city has to update its fire code. It was pointed out by Van Buren Township. It can be done by ordinance and Jones said he would get a copy for the next meeting on Feb. 17 for the first reading and then on March 1 they could have the second reading and adoption. He said they also need to do the same for the building and electrical codes. The city can't find proof in the files that these had been updated. Mayor Voigt said in the past the city hadn't had good record keeping;

- Heard Mayor Voigt said the father with a gun at Romulus Middle School recently and a suicide in front of the Canton Township

administration building has brought him to the realization that the city needs an Assailant Policy. He said he asked the Canton Township supervisor for a copy of its policy and it has been given to the city attorney for review and options;

- Heard Jones report the city had IT shortcomings and all of its servers are going to be cleaned up and backed up for clean copies to be on the new hardware at the new city hall. They are preparing everything for the move, he said. He reported attending a Wayne County Parks meeting and learned how the city's parks millage can be rolled over for three years if desired to cover bigger projects. He also reported officials sat down with Hennessey Engineers and learned the city currently has seven open projects in the

works;

- Heard councilwoman Julie Kissel report that in her organizational efforts at city hall she discovered the old, folded map of the cemetery being used and they have ordered scanned maps and printed maps; and

- Heard mayor Voigt invite everyone to the Mayor's Ball which will be at 6 p.m., Saturday, April 25, at the BYC. He said it will be a gala event to benefit the Friends of Michigan Animals Rescue. This is reinstatement of the Mayor's Ball that former mayor Kerreen Conley used to have in conjunction with the Romulus mayor to benefit Boys and Girls Clubs. He said donations of baskets for auction will be welcomed.

This issue is full of information on data center, salaries

This issue is heavier than the usual paper this time of year because of the data center proposed for Van Buren Township that will be discussed at the 5:30 p.m., Feb. 11 planning commission meeting.

VBT has published many pages of frequently asked questions and VBT's answers. This information is also on the VBT website.

We expect the Feb. 11 meeting to be a barn-burner that may last many hours with all the local opposition to the data center.

The developer of the data center also has added a page of information for our readers to consider before that Feb. 11 meeting.

We don't see any detail yet that the planning commission can use to block the data center, unless something new shows up. Otherwise, if the company is unable to use its property under the present ordinances and VBT says no, here comes the big lawsuit.

Also in today's paper is the beginning of our annual transparency report on salaries in the five municipalities, school district, and library district that area taxpayers provide with their hard-earned money.

We have six units that we usually provide information on, but Keystone charter school is opting out again this year, based on the fact its employees are hired by a private company, NHA. Keystone started that opt-out last year after 10 years of cooperating with salary numbers. The salaries we were able to get through FOIA will be printed as space allows.

EXTRA THINGS I KNOW

Crain's Detroit Business ran a story on Monday about a data center developer who wrote proposal letters to nine municipalities across Michigan on Jan. 16, giving them 48 hours to respond (up to 5 p.m. on Martin Luther King Day).

The company offered a \$285 million data center that would effectively use zero water, capturing up to 50,000 gallons per day from the atmosphere, and not tap into the power grid by using a battery energy-storage system underneath the facility with power from solar panels, instead.

Van Buren Township supervisor Kevin McNamara got one of the letters and *Crain's* quoted him. He said there were several "red flags" with the proposal including the short timeline for a commitment, even though it was non-binding. He also said the developer's desire to use a brownfield site would mean local tax dollars would subsidize the project.

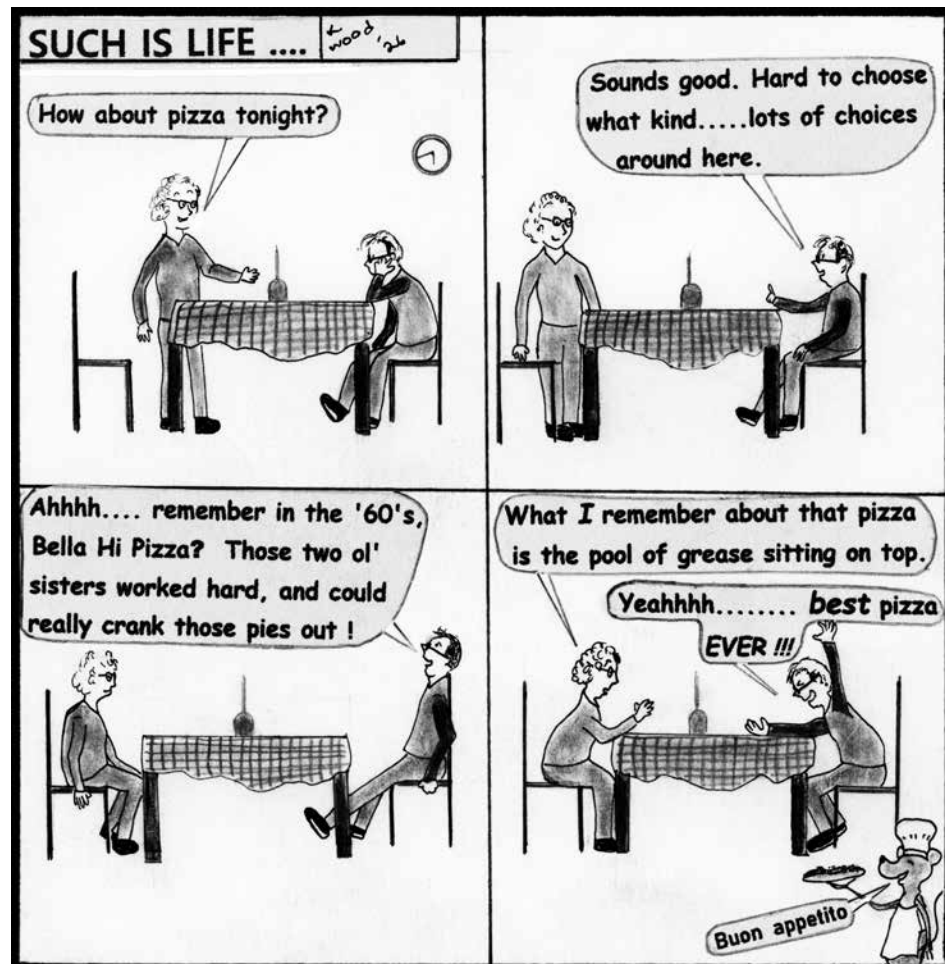
"I get nervous when people say they want to have it now," McNamara said, adding that local incentives for such a project would be a nonstarter for the township.

Sandy Crout, BHS class of 1965 and now of Romulus, sent us a letter to the editor for publication in our Jan. 8 edition. She said she had a problem with the Romulus City Council's move to change the way it replaces council members who leave the council before their terms are up.

She said she wrote to the *Independent* because Romulus didn't have a newspaper.

We published her letter and she reported that at the Jan. 26 council meeting, the new ordinance was up for its second reading and adoption – and it failed. She was so

surprised but pleased.

She was in favor of continuing the present method of taking the next candidate down on the returns, who in the last election had the most votes, but not enough for election. She said that way the voters still had a say, instead of a new routine that would set up a procedure where people could apply for the seat and get scores that could bring the council's friends onboard.

At the Jan. 26 meeting, the vote was 4-3 in favor of passing the new ordinance, but they needed five votes to pass an ordinance, so it failed. Sandy had spoken under public comment at the Jan. 26 meeting, again asking the council not to leave the voters out of the decision on a council member. Speaking up can work.

A reader called to voice her frustrations on Ecorse Road. It's that there are no shoulders on Ecorse, between Belleville and Denton roads, but there is a rut along the edge that throws cars into accidents. She said a salt truck tipped over on the edge last week. She said she's talked to Wayne County about this and the township.

About all she can do now is give a safety tip to drivers: If you have to pull over there, slow down before you turn. It could save you. She said she drives that route every day for school and sees what happens. Please, she said. Be careful along that part of Ecorse.

Belleville High School was evacuated at about 12:30 p.m. Thursday, Jan. 29, for what supposedly was a fire in the kitchen. But School Supt. Pete Kudlak said: "No. There was no fire at all. It was an alarm system fault. It would have worked correctly if there had been a fire. However, the company came out that afternoon and serviced the system. The fire department did a wonderful job clearing the building and getting our students back inside as quickly as possible."

We also heard a fire called in on Peninsular Drive in Van Buren Township at about 11:20 a.m. Sunday. We asked Fire Chief McNally about it and he replied: "No, it was called in as one but did not turn out to be a fire. We did have a small fire Morning Bell (old Twisted Rooster) on Friday morning. It was some rags on top of a freezer, no fire extension problems. This morning [Monday] we had a garage fire behind a house that had a fire last summer on Ecorse just East of I-275 on the North side of the road. Male who lives there is still on site in his camper. Canton, Romulus, Ypsi Twp. responded to the scene, while Belleville FD took a medical call for us."

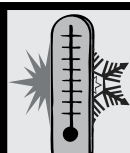

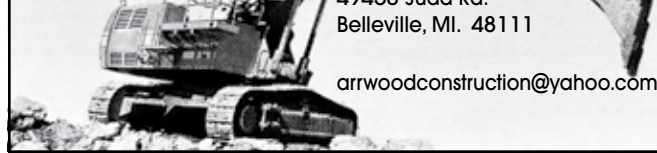



Another car wash on Belleville Road?

Editor's Note: Mike Suliman has retired from running the family's Water Works Auto Wash businesses in Van Buren Township and moved to Florida. His son Bryan, an attorney, has been running the businesses and wrote a statement to present to the Van Buren Township Planning Commission at the Jan. 28 public hearing on the request for a new car wash on Belleville Road. Bryan did not wish to appear in person at the public hearing, so Mike flew up from Florida the night before the meeting so he could appear on behalf of their businesses. But, the public hearing and two other items on the agenda were removed from the agenda by the applicant before the meeting. Mike's flight from Florida was in vain and so he brought a copy of the statement to share with the public through the *Independent*.

To: The Van Buren Township Planning Commission

RE: Comment on Proposed Zoning Change 25-025 – Proposed Car Wash

My name is Bryan Suliman and I am the managing member of Water Works Auto Wash. I am a third-generation car wash operator, and our family has operated car washes in Van Buren Twp. and the City of Belleville since 1966. I apologize for my absence this evening, but I cannot bear to watch what will be very likely the beginning of the end of our family business.

In short, should this special land use be permitted and yet another car wash be built in our community, Van Buren Twp. and the City of Belleville will have more car washes per capita than any other community in Southeast Michigan, if not the entire state. *Please see attached Exhibit A for a list of car washes in 91 communities that make up Wayne, Washtenaw, Oakland, and Macomb counties.*

The addition of another new car wash in our area goes beyond competition. It will be a clear over-saturation of the market in terms of customer base needed to support so many car washes. It is common knowledge within the car wash industry that there should generally be no more than one car wash per approximately 15,000 people in a geographic area to ensure a healthy business. Coincidentally, this is approximately the average per capita amount of car washes per person in Southeast Michigan (14,289). Please see Attached Exhibit A.

Based on the recent 2024 US Census survey data, the City of Belleville and Van Buren Twp. have a combined population of 33,367, which has remained relatively consistent for the past two decades. As of the date of this comment, the two

Project Cannoli Data Center Frequently Asked Questions (FAQs) 1/6/2026:

Project Cannoli is a proposed data center project which is located near the I-94/Haggerty Road area. Over the past several weeks the Township has been asked several questions regarding the project and we wanted to provide responses to those questions so our residents had the opportunity to review them prior to the Planning Commission meeting. Please see below for specific questions and answers to those questions related to the development.

For more information about the data center project please visit the Van Buren Township website www.vbtmi.gov. On the home page there is a link to a dedicated data center page which has information about the project including the site plan.

Who is the developer?

A: Panattoni is a private, family-led industrial real estate developer established in 1986. Since inception, the company's approach to all projects has been to focus on long-term quality, efficient site planning, and alignment with the priorities of each community they build in.

Who is the end user?

A: Per the Developer, Panattoni is developing this project for a Fortune 50-company with data center operations worldwide. The company has been consistently rated as one of the top companies to work for in America and would be an ideal long-term partner to the community.

What type of data center will this be?

A: This will not be a bitcoin or crypto mining operation. The proposed data center could be used for a number of applications, varying from cloud computing to machine learning.

When will Project Cannoli be before the Planning Commission for consideration?

A: The proposal will be before the Planning Commission on Wednesday, February 11, 2026 at 5:30 p.m. for preliminary site plan approval consideration. The meeting will be at Van Buren Township Hall.

What is Township Staff's Role in Interacting with Prospective Developers?

A: In the Planning & Economic Development department it is our job to communicate with and advise prospective businesses/developers, residents, and homeowners regarding utility needs, zoning regulations, building codes, economic development requirements, approval processes, and other relevant development guidelines. It is very common for us to have substantial discussions with a developer or a homeowner which span over extended periods of time, prior to them deciding if they will be submitting an application for that project. Under the same scenario it is common for a developer to consider several different options for a development and layout of a site prior to moving forward with a proposal.

How Long Has the Township Been Interacting with Panattoni About This Project?

A: The Township has been in communication with Panattoni about this property since at least January 2024. We have been having discussions with Panattoni regarding different development options, uses, and layouts on the site since January 2024 and have seen a variety of options and proposals for this property. The initial proposals were for an industrial park which would have accommodated warehousing uses and high tech manufacturing. Further proposals focused more on larger warehousing users which were considering sites within the area.

The Township answered questions regarding height and zoning requirements for data center developments in late 2024/early 2025. The Township did not have conversations about a potential data center development attached to a specific end user until summer 2025 and the Township was not aware that there would be any formal submissions for this development until late October/November of 2025 and once we knew this we began working with them to plan for the open house in December 2025.

Can the Township just make data centers illegal?

A: No, MCL 125.3207 (Michigan Zoning Enabling Act) prohibits a municipality from having the effect of totally prohibiting the establishment of a land use within a local unit of government unless the use is unlawful. Can the Township enact a moratorium to stop or slow down this proposed data center development like other communities in the State have?

A: Not without significant potential for liability. Other communities have enacted moratoriums prior to a site plan being submitted for review. The majority of requests in other communities were applications to rezone property to a zoning district which would allow for the submittal of a site plan tied to a data center development. When a site plan is submitted the plan is locked into the standards that are in place at the time of submission.

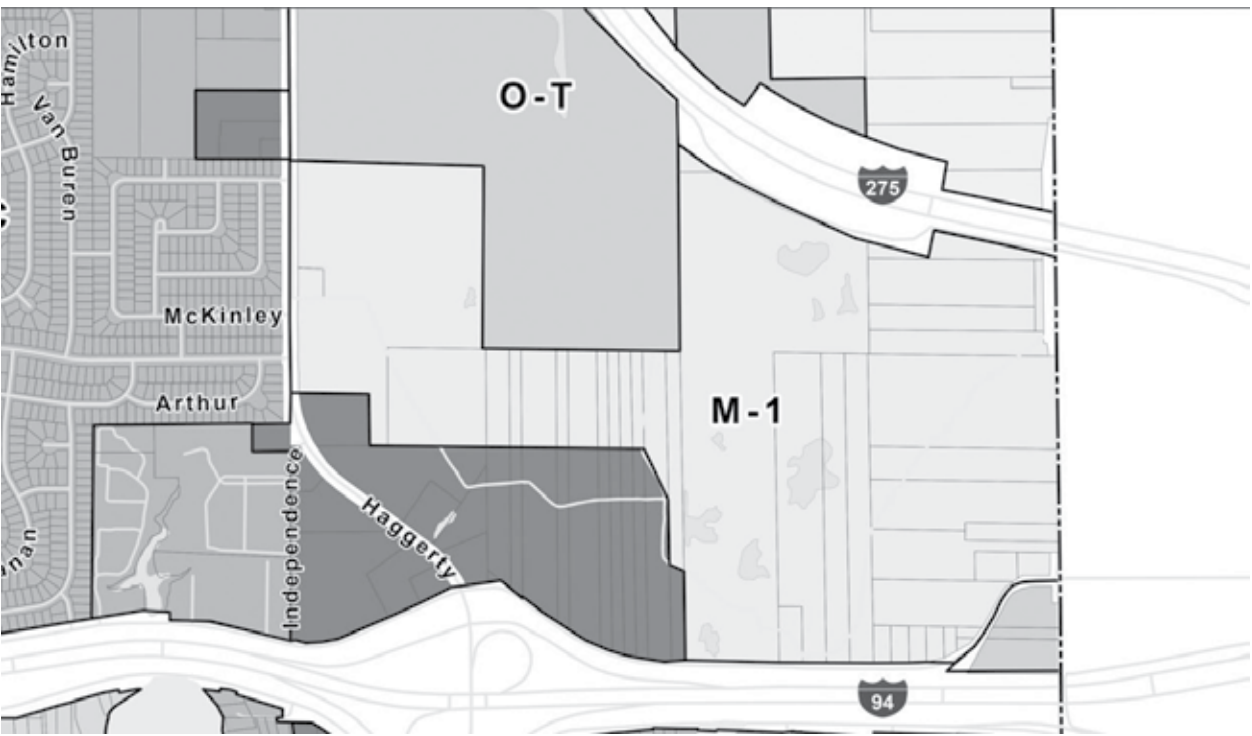
To delay a proposed development and change the regulations that they submitted plans under, would open the Township up to liability and would likely limit our ability implement any of those changes that would have been enacted. Applicants generally have a protected interest in being considered under the existing regulations if the application is submitted prior to the moratorium being enacted. Township staff did consult with our legal counsel regarding this question.

Based on the public feedback received on the project it is likely the Township will evaluate our existing standards to see if they meet current best practices. Any changes to the Township zoning ordinance from this effort would have no impact on the current submittal for the proposed development, but may have impact on future site plan submittals.

Zoning

What is the Zoning of the Property and Does It Allow Data Centers?

A: Most of the property is zoned M-1, Light Industrial, with a portion of the property being zoned C-1, General Commercial. The M-1 zoning district allows “High Tech, Data Processing, and Computer Centers” as a “Permitted Use” in the district. The proposed data center buildings are located within portions of the property zoned M-1. There is a proposed area for an office building and a substation in the C-1 portion of the property. Both are allowable uses in the C-1 district. Please see below for an image from the Township’s zoning map.



When was the Zoning of the Property Changed?

A: The property has been zoned M-1 Light Industrial since at least 2005. Prior to this in the late 90’s the property was under a different designation called, “Business Office District.” The Township’s Zoning Ordinance was amended in 2018 to allow “High Tech, Data Processing, and Computer Centers” as a permitted use in the M-1, Light Industrial and M-2, General Industrial zoning districts. The use was allowed as a permitted use in the OT, Office Technology zoning district since the early 2000’s.

What is a “Permitted Use”?

A: There are two types of land use designations in the Township’s zoning ordinance. These are “Permitted Uses” and “Special Land Uses.” A “Permitted Use” is sometimes referred to as a use by right in a zoning district. It is a use which is automatically allowed in a zoning district if it meets the standards of the zoning ordinance. A “Special Land Use” is a land use which generally fits the zoning districts purpose, but needs discretionary review and approval because of its unique features which may be more impactful on neighboring properties. “Special Land Uses” also

communities currently have a total of five car washes for an average of one car wash per 6,673 residents. This places us fourth per capita in car washes per resident in all Southeast Michigan. For some perspective, our neighbor, Canton Twp., has three times the population of Belleville and Van Buren Twp. with six car washes, for an average of one car wash per 16,632 residents.

If the special land use and proposed new car wash is ultimately approved, we will have one car wash per 5,561 residents – a greater per capita total than any municipality in Southeast Michigan. We will also have more tunnel car washes (three) in a closer proximity to each other (1.12 mi.) on a single road (Belleville Rd.) than anywhere else in the region. We will have three times more car washes than the average amount per capita in Wayne County. We will have almost five times as many car washes per capita than Washtenaw County. It is further worth noting that there are an additional five car washes within ½ mile of the borders of Van Buren Twp. The population will not sustain the number of car washes in the community.

The Planning Commission has it within its jurisdiction to not grant this special land use request based on the reasons as set forth in Section 12.305 & 12.306 of the Charter Township of Van Buren Zoning Ordinances. Van Buren Township is obviously aware of the glut of car washes in our area, hence the recent moratorium on new applications while a zoning ordinance can hopefully be enacted. The members of the Planning Commission should ask themselves if having more car washes than any other municipality in the County, Southeast Michigan, and likely the State of Michigan benefit its residents in a way that supports the special land use request. I submit that it does not.

A car wash is not a typical retail property. Meaning, a car wash cannot easily convert to host a different type of business in the manner that a standard retail outlet would. Unfortunately, if one car wash fails due to the excessive number of car washes in our community, that site may sit vacant for years, even decades. There are examples of this in both Ypsilanti Twp. and Saline. This is not out of the realm of possibility for our site. We will not operate a business that no longer remains profitable. Should it come to it, and I cannot tell you how many nights I lay awake thinking about it, we will be forced to shut the doors and end a business that has been in the community for three generations over the past 60 years. The Planning Commission’s decision in this matter will have a direct impact on whether one of its longest-running family businesses continues to exist.

It is in the purview of the Commission to determine land use for the best interest

of its residents and community at-large. Should the rezoning request be approved, the Tri-Community will have more car washes than:

- Grocery stores – 3
- Pharmacies – 5
- Urgent cares – 2
- McDonalds, Wendys, Burger Kings, and Taco Bells combined – 6

I sincerely hope that the members of the planning Commission take the above facts and circumstances into account and vote no to the proposed special land use. There simply will not be enough of a population base to support the number of car washes in the area if the special land use is approved. While it may be easy for those on the Commission to see this rezoning request as just another opportunity to develop a vacant parcel, it is much more than that to us and our employees as our livelihoods are impacted in a way that is hard to put into words.

There is a start difference between competition and over-saturation. We currently have more car washes than almost anywhere else in Southeast Michigan. Please do not add more. Being number one is not always a good thing.

Tri-community planning commissions meet to discuss mutual issues

Members of planning commissions from the city of Belleville and townships of Sumpter and Van Buren met for an hour-long session on Jan. 29 at Belleville High School to discuss their individual projects and to speak on local issues.

Four members of each commission attended the meeting and Van Buren Township Planning Commission Chairman Brian Cullin was chosen to lead the meeting.

The next joint meeting for the three communities was set for 5 p.m., July 29, at Belleville's new city hall at 330 Charles St.

The meeting began with public comment by a man who did not identify himself but wanted to talk about the dangers of the data center planned in Van Buren Township.

Chairman Cullin asked Ron Akers, director of municipal services in Van Buren Township, to explain.

Director Akers said the information that the township has is on the township website for the public to study. It also will be published in the *Independent* in the Feb. 5 issue.

He said the developer will be before the Van Buren Township Planning

allow for certain conditions outside of the zoning ordinance to be placed on the approval.

What Other Uses are Allowed in the M-1, Light Industrial Zoning District?

A: Please see below for the list of allowable uses in M-1:

Article 3: Zoning Districts and Permitted Uses

Section 3.115 M-1, Light Industrial District

(A) STATEMENT OF PURPOSE
In the M-1 District, it is intended that limitations placed upon the degree of noise, smoke, glare and other features of light industrial operations shall make such uses compatible with nearby commercial and residential uses. It is further intended that some light industrial uses shall act as a transition between heavy industrial uses and non-industrial uses and shall not require railroad access or major utility facilities. Certain commercial uses which are desirable to serve the employees and visitors of the industrial uses are also permitted in this district.

(B) PERMITTED USES	(C) SPECIAL LAND USES

Is the Data Center Project considered a Planned Unit Development (PUD)?

A: No, the data center proposal is not proposed as a PUD. Due to this it was not subject to the standards of that section of the Zoning Ordinance.

Did the PUD Zoning Ordinance amendment change the Zoning Ordinance to allow more Data Centers?

A: No, the PUD zoning ordinance amendment is a tool that could be used to allow for flexibility in zoning guidelines on any eligible property in the Township. In order to be used, an application would need to be submitted by an applicant and any exceptions to the zoning would need to follow the guidelines in Article 6, Chapter 5 of the Township's zoning ordinance.

The amendment to the zoning ordinance created the language and guidelines for the tool, but that tool and those provisions were not used by Panattoni for this development nor does it expand data centers use in the Township. The property under consideration for Project Cannoli was already zoned M-1, Light Industrial which allowed for data centers as a permitted use.

Does this data center match up to the current definition of a data center in the Zoning Ordinance?

A: In the Township’s Zoning Ordinance data centers are under the land use “High Tech, Data Processing, and Computing Centers.” This use is defined as follows:

“(109) HIGH TECH, DATA PROCESSING, AND COMPUTING CENTERS: Uses include, but are not limited to, alarm and security businesses, phone message centers, telemarketing businesses, data processing and computer centers (including service and maintenance of electronic equipment and other computer related services), and high technology service uses which have as their principal function the providing of services, including computer information transfer, communication, distribution, management, processing, administrative, laboratory, experimental, developmental, technical, or testing services. “High Tech, Data Processing, and Computing Centers” that are smaller scale and are primarily office uses may be classified by the Planning Director as an “Office, Professional” use.”

The current definition does not have any differentiation between “hyperscale” data centers and other smaller data centers. Due to this the proposed Project Cannoli can be considered under this definition and land use.

Water:

How are the Data Center Buildings Cooled?

A: Per the developer there are three (3) data center buildings proposed on the property. One (1) building is proposed to be cooled using an “open loop” method and the other two (2) buildings are proposed to be cooled using closed loop and/or forced air methods. Both closed loop and open loop methods use water. The open-loop method uses a much higher volume of water; the closed-loop system uses nearly zero water for cooling.

How Much Water will the Data Center Use and Where will the Water Come From?

A: Per the developer the estimated water usage for the data center project is somewhere between 2 to 3.6 million gallons per day. The data center will be required to buy water from the Township for cooling purposes. There is no proposal from the project to take any water directly from surface water, ground water, or aquifers as a part of this project.

Can the Township Provide That Much Water to the Project?

A: Van Buren Township purchases drinking water from the Great Lakes Water Authority (GLWA) to supply to our customers. The GLWA draws water from Lake Huron and the Detroit River and supplies drinking water to 80+ communities in Metro Detroit. The Township water system has several connections to GLWA distribution/transmission mains which act to stabilize water pressure and provide redundancies in our water service capability. These large diameter water transmission mains supply water to Van Buren Township as well as communities to the west and north. The data center project is proposed to be served by a 24” inch water line which directly connects to a GLWA 42” transmission main near the Tyler Road and Haggerty Road intersection. This connection will be for the cooling water, there will be a second water connection for the office building on site to provide domestic water to the site.

Both the Township Engineers and the GLWA Engineers have reviewed the water demand for this project and have determined that the GLWA system has the available capacity to handle this demand without having an effect on the Township’s or GLWA’s ability to provide water service to our water customers.

How Will This Project Affect My Water Pressure?

A: It will not, the data center will have a direct connection to the GLWA transmission main and the data center process water lines will have no direct connections to the Township’s internal water system. After the connection the GLWA will still be able to provide its contractual service to the Township as well with little pressure changes in the transmission mains. Due to this there should be no impact on the Township customers related to this project.

How will this Affect My Water Bill?

A: This project will not affect Township customers' water bill. The developer will be paying for all infrastructure upgrades and installation. The Township will be selling this water to the end user and this project should provide for a large increase in revenue related to water sales with little increase in staffing or other operational costs for the Township. The Township has our rates reviewed annually by a rate consultant which helps us establish fair rates for our customers. This increase in revenue from water sales should be a benefit to the customer base because it adds a large amount of revenue to the system which has a positive effect on overall customer rates.

Commission at 5:30 p.m., Feb. 11, with a site plan request.

The man made comments that the power needed to run this data center would power one million family homes. He complained about pollution, noise, and air pollution he saw coming.

Akers said it will use a lot of water, but it will be getting its water from a distribution line directly from the Great Lakes Water Authority, from which it will purchase the water.

He said the sanitary sewage line also will go directly to downtown.

Akers said the electricity will come directly from the ITC line to the substations through a buried line.

“It’s not going to impact us at all?” the man asked. “I’m amazed it can be allowed in a residential area. The humming can drive you crazy.”

Akers went over to the table where the man was sitting to get his contact information and talk quietly with him as the meeting continued. But their conversation was too loud and disturbed the meeting. Finally when those in the meeting protested, Cullin asked the two to move into another part of the room to talk and they did.

Belleville city councilwoman/planning commission vice-chairperson Julie Kissel gave a report on Belleville’s projects. She started by saying the new city master plan is out for its 63 day review period. She asked them to look over the master plan and tell the city what they think.

Kissel said there are printed copies of the hefty master plan at city hall and at the district library for people to review. It is expected back on the planning commission agenda in March.

Belleville’s interim city manager Steve Jones listed seven open projects going on, including putting the final touches on the new city hall.

Cullin asked about the empty CVS and hardware store on Main Street and Jones said they tried to put pressure on CVS to sublease the store, but the rent is being paid to the store owner in California, so there is no loss to the owner if it stays vacant.

He said the details of the hardware store, now owned by the Downtown Development Authority, is now in the hands of a new committee that had been formed and is meeting regularly.

Van Buren Township was next on the agenda to tell its story and township DDA director Merrie Coburn told of the Belleville widening project now on hold, the work to find a plan for the 180 acres owned by the township at the northwest corner of Tyler and Belleville roads. She described other projects under way.

Coburn said they are looking at how to increase connectivity for the three communities. She described a minigrant and a SEMCOG grant that could be applied for to fund a sidewalk from Owen School to downtown Belleville.

She said they knew they needed to get the school involved and NewTech at Belleville High School is helping to get information on the students that would use the sidewalk.

Coburn said she is working on getting support staff in her office and that will help with moving forward.

Director Akers went over a long list of projects under way, including the Denton Road Bridge, the paving of Morton Taylor north of Tyler, providing building services to the city of Belleville, the occupation of Clover Community building on Belleville Road, senior housing on the north side of Tyler which will be 24 single-story units for rent only with garages, overlay districts, coming completion of Tractor Supply at Sumpter/Hull roads, reconstruction of McDonald's, construction at U.S. Signal and Ashley Capital, and a car wash that was tabled by the planning commission the night before.

Belleville commissioner John Juriga asked about the erosion going into the lake. Akers asked where specifically and Juriga said you have to get on a board to see it, but some is on property owned by Van Buren Township.

Akers said the township's parks people are looking at it presently to find options. He said the township has hired a firm, Progressive, to look at solutions for the lake, including invasive species. The study will be completed in the spring.

Sumpter Township trustee Matt Oddy, who is liaison to the planning commission, gave Sumpter's report.

He said the township had a lot of turnover, with the township manager, DPW director, and finance director changing. Oddy said they brought on Carlyle Wortman to run the building department. They are working on a moratorium on data centers and already have a moratorium on wetlands.

He said wetlands are being declared by the state and it is taking prime farmland and making it wetlands. He said they took property next to a mobile home park and didn't have to tell anybody but the park owners. Nobody in the township knew it was happening, he said.

He said State Rep. Reggie Miller is working on legislation on this.

He said the township is working with the county on Judd Road paving from Bohn to Rawsonville, as an emergency in the community. Fire trucks are delayed on getting to the Rawsonville Woods area, when a large number of calls originate.

He described 1.6 miles of water main being replaced on Willow Road and a sewer pump station to get back up on Martinsville.

Also, currently a house on Savage Road is being remediated since it had been given a landfill permit in 1972 or 1980 and the property is contaminated. He said you can see the house and property is taped off from the public.

Oddy said, among other things, the

Will the Data Center Project Use Surface Water, Ground Water, or Water from an Aquifer?

A: No, the project is not proposed to take any water from the ground. This cannot be done without first obtaining approval from the Michigan Department of Environment, Great Lakes, and Energy (EGLE) and Wayne County Environmental Health. There are extensive studies and permitting procedures required to do this.

Will there be any additives used in the process water?

A: Per the developer, the cooling water will use trace chemicals to optimize system performance which we review with the utility to ensure that no harm will come to the municipal wastewater treatment system or downstream receiving body as a result of their use in our system.

Sewer

Will the Data Center Discharge Any Water to Edison Lake/Belleville Lake, or Any Surface Water, Ground Water, or Aquifers?

A: No, there is no proposal for the data center to discharge any water to Edison Lake/Belleville Lake or to any surface water, ground water, or aquifer. It was discussed as a potential option and there was a meeting with residents who live along Edison Lake to discuss this early in December, but the developer made the decision to not pursue this due to concerns raised by the residents at that meeting. Any waste water from the site will be discharged into the Township's sanitary sewer system which will transport the water to a waste water treatment plan in Brownstown Township near Gibraltar, MI.

Will the Amount of Water Going into the Sewer Cause Any Issues?

A: No, the Township recently completed an assessment of our sewer system where we evaluated our capacities and our current flows during dry and wet weather circumstances. We have limited the applicant's sewer discharge to approximately 750,000 gallons per day and we will monitor the volume to ensure they do not exceed this limit. This number in coordination with some storage during wet weather events will allow us to maintain our commitments to provide sewer services to other properties in the Township without issues.

Stormwater

Will the Development Create Flooding Issues in the Area?

A: No, all new commercial/industrial development sites are required to develop infrastructure to manage stormwater on their own property. These systems are designed to store excess rainwater from storms and slowly release this water into drains and waterbodies to ensure that those drains do not become flooded with too much water at one time. These systems also promote water quality by filtering out any sediment as well.

Will Any Cooling Process Water Enter the Storm Water System?

A: No, the storm water system is separate from the process water discharge which goes into the sanitary sewer. These systems do not mix or combine their water as it is not allowed by Township Ordinance or State law.

Sound & Other Environmental Performance Concerns

What are the Township's Ordinances for Noise & Other Environmental Performance Standards?

A: Article 8 of the Township's Zoning Ordinance includes environmental performance standards that we apply to any industrial properties. These standards include gases, exterior lighting, noise, odors, smoke, vibration, and tree removals. A link to the Township's Zoning Ordinance can be found here:

What are the Township's Noise Standards in the Zoning Ordinance?

A: The following are the Township's Noise standards in the zoning ordinance:

(K) Noise. The pressure level of sounds shall not exceed the following decibel levels when adjacent to the following types of uses:

*except where normal street traffic noise levels exceed sixty-five (65) dBA, the use noise level may equal but not exceed the traffic noise level.

- (1) The sound levels shall be measured using a weighted decibel measurement and with a type of audio out meter approved by the National Institute of Standards and Technology.
- (2) Objectionable noise as determined by the Board, of an intermittent nature or high frequency sounds, even if falling below the aforementioned decibel reading, shall be muffled so as not to become a nuisance to adjacent uses. This shall particularly apply to loading and unloading areas in commercial or industrial districts adjacent to residential districts.

Will the Noise Survey Be Made Available to the Public?

A: Yes, the developers noise survey is available on the Township website.

What are the Township’s Standards for Vibration?

A: The following are the Township’s standards for vibration in the Zoning Ordinance:

- (O) Vibration.** All machinery shall be so mounted and operated as to prevent transmission of ground vibration exceeding a displacement of .003 inches as measured at any property line of its sources.

What are the Township’s Standards for Exterior Lighting?

A: The Township’s Exterior Lighting standards are in Section 8.105 of the zoning ordinance. A link to the Township’s Zoning Ordinance can be found here:

The standards are too long to post in this document, but the zoning standards limit the amount of light and glare that extend beyond property lines and the standards require the light fixtures to direct their light toward the ground. The effect of these standards is limiting “light trespass” onto adjacent properties.

What are the requirements for Diesel Generator Exhaust?

A: The Township’s zoning ordinance limits the noise and vibration from the backup generators as described above. Backup diesel generators are required to meet emission standards set by the Environmental Protection Agency (EPA) and may require an Air Permit from the Michigan Department of the Environment, Great Lakes, and Energy (EGLE).

Per the developer, the client will use Ultra-Low Sulfur Diesel (ULSD) and high-performance exhaust scrubbers that remove 90%+ of particulates. At the property line, there is no detectable odor or smoke. Furthermore, the generators are Tier 4 Final compliant—the EPA's highest standard for clean air.

Wildlife & Wetlands

What is the Developer Doing to Limit Impacts on Wildlife?

A: The developer is only planning on developing 150 of the 282-acre property. They are also ensuring that security fencing is being brought tighter to the buildings to ensure that wildlife can maneuver around the property. The applicant has also designed their site around existing creeks and drains on the site.

What is Being Done About the Eagles Nest on the Property?

A: We have received reports that there was an eagle’s nest on the property. On the most recent site plan submittal, there is a 200’ separation buffer on the most recent site plan submittal for the location of the eagle’s nest, with a note that indicates the contractor will need to maintain this buffer during construction. EGLE is also aware of the

township is revisiting the solar ordinance so large projects will be only in the industrial zone.

Cullin said the joint sub-committee of the large tri-community group will meet again in March.

Akers was asked about Camping World and he said the business has had its certificate of occupancy for several months and said it wants to open in the spring.

VBT planners give final site plan approval to huge Stellantis project

At its Jan 28 regular meeting, the Van Buren Township Planning Commission unanimously approved the final site plan for the 2,111,200-square-foot Stellantis warehouse on Ecorse Road between Denton and Beck roads.

Vidya Krishnan, planning consultant from McKenna Associates, said the preliminary approval of this project, dubbed Project Venture, was last July and the recommended changes have been incorporated.

The guard house is prefab and while it is utilitarian, planners would like to see some added features. She said the Zoning Board of Appeals approved the wall and monument signs.

Krishnan said all the barbed wire fencing has been removed and a special mesh is part of the fence so employees can’t pass anything through openings in the fence. There will be 670 new trees planted on the site.

Fishbeck engineer Paul Kammer announced, after meetings with the county, that all the trucks exiting the warehouse have to head west to Michigan Ave. There will be 690 employees and 100 trucks per day. There is employee and emergency access to Denton Road and an emergency access to Beck Road. The Ecorse Road access is for trucks only.

Kammer said there will be four detention ponds and Wayne County has allowed dry detention ponds, along with the township board so they won’t have to be so deep to be wet.

A member of the public said the township residents deserve more than one engineering firm – Fishbeck – and one planning consultant – McKenna – to look over the plans for this huge facility.

“I drive through my township and see the apocalypse,” she said. “We should have second consultants.”

Director of municipal services Ron Akers said the township hires these outside consultants for their expertise. He said Fishbeck has a lot of experience and McKenna has a large number of consultants and the township relies on their expertise.

In other business at the Jan. 28 meeting,

the commission:

- Heard two residents speak on the data center being considered, but not on that night's agenda. The first speaker thanked the township for putting information on the website and the other said there should be a moratorium in place for hyperscale data centers. She said the township residents have asked for a moratorium. She said while other communities are enacting moratoriums in a proactive manner, Van Buren is being reactive;

- Was informed that the day before removed from the agenda at the request of the applicant was the public hearing, the special land use request, and the preliminary site plan approval for El Car Wash and Commercial Development at 10525 Belleville Rd., 10501 Belleville Rd., and 10401 Belleville Rd. The applicant was seeking to provide express (automatic) exterior automobile wash services and self-serve vacuuming, along with a 7,108 square-foot building comprised of four restaurant tenant spaces, including one offering drive-through service;

- Voted to direct consultants to draft an amendment to the ordinance on Cul-De-Sac length. Akers said a question had come up on this when Pulte was planning a residential development at Tyler and Morton Taylor roads. The amendment would shorten the cul-de-sac from the present 1,200' to a reduced 600' as a matter of safety. Commissioner Jeff Jahr asked if emergency crews can get in there and if 1,200' feet is a problem, shorten it;

- Heard Akers announce the only item on the Feb. 11 planning commission meeting will be the data center. Frequently asked questions are answered on the township's website and will also be published in the Independent. He also reported a national scam where residents are asked to pay municipalities for legal action or fees. "VBT does not demand money by email. USA.com is not legitimate. Do not respond or send payment. The township never asks you to wire money to it," he stressed;

- Heard commissioner Jahr comment that he is angry at comments that say the township's staff is not the most proficient group. He said the township doesn't look like a wasteland. "I do this job because I feel I have to give back. I don't appreciate it and I don't believe it's true," he said of comments criticizing the work of the planners. "I believe Van Buren Township cares dramatically about planning. We have the best consultants in the state. They have resources to see what other communities are doing. We ask tough questions from highly selected professionals," he said;

- Heard treasurer Sharry Budd, the board's liaison to the planning commission, say the board reviewed several planning and engineering consultants before selecting these. "We all live here. I live here. My kids live here," she noted, saying she wants the best for the township;

eagle's nest location as well.

Who is Responsible for Regulating the Wetlands on the Property?

A: The Michigan Department of Environment, Great Lakes, and Energy (EGLE) requires an applicant to obtain a permit if they are proposing to fill in any regulated wetlands. These submittals undergo extensive reviews and the developers are required to replace the wetlands they remove at a minimum 2:1 ratio. Is the Developer Getting Rid of Wetlands on the Property?

A: The developer is proposing to fill in approximately 10 acres of wetlands on the property. Of the 282 acres of property, approximately 130 acres will remain undeveloped. The developer will need to replace the wetlands they fill in and are required to go through permit reviews with EGLE.

Where Can I Find More Information About Wetlands & The Developer's Permit Application?

There is an Eagle's Nest on the Property. What is Being Done to Protect the Eagle's Nest?

A: The applicant has proposed at 200' buffer around the location of the Eagles Nest to avoid disturbing them during construction. This will be on the updated site plan once it is submitted.

Power/Electricity

How Much Electricity Will This Data Center Use?

A: Per the developer this project is being developed as an approximately 1 gigawatt data center.

Can DTE Provide That Much Power to the Site?

A: DTE has provided the developer with a "will serve" letter for the project confirming they can provide power to the site. A "will serve" letter is a document that provides a commitment from a utility to provide the project with service at the specified load. Power will be delivered via a dedicated substation, paid for by the customer, connected to the existing high-voltage transmission lines.

How Will This Project Affect Utility Bills and Power Reliability?

A: DTE made the following statements in a letter to the Township for the project:

"During the community open house, residents raised understandable concerns regarding reliability and affordability. We take these concerns seriously and believe it is important to clarify that state law and Michigan's regulated utility market offers protections to DTE customers from bearing any costs associated with data centers. In fact, existing customers are positioned to benefit when these large energy users join the electrical system that serves southeast Michigan.

Michigan's bipartisan law that is attracting data centers to the state requires that projects pay their own way, ensuring residential customers are not subject to higher costs or subsidized rates when these projects are developed. Moreover, investments in utility infrastructure are not unlike investments made into municipal infrastructure. When large, energy-intensive users become part of DTE's customer base, costs to improve and maintain the system are spread more widely, creating an affordability benefit for all customers. Given the scale of infrastructure investments DTE is making on behalf of its customers, the timing of these projects coming to our electric service territory is fortuitous.

In recent years, DTE Energy's electric company has invested significantly to improve the reliability of the local electric distribution grid serving Van Buren Township. This includes upgrading out-dated infrastructure and trimming trees to reduce both the frequency and duration of power outages. Our grid improvement work is happening across southeastern Michigan to improve reliability during severe weather events and meet the electricity needs of our customers for decades to come.

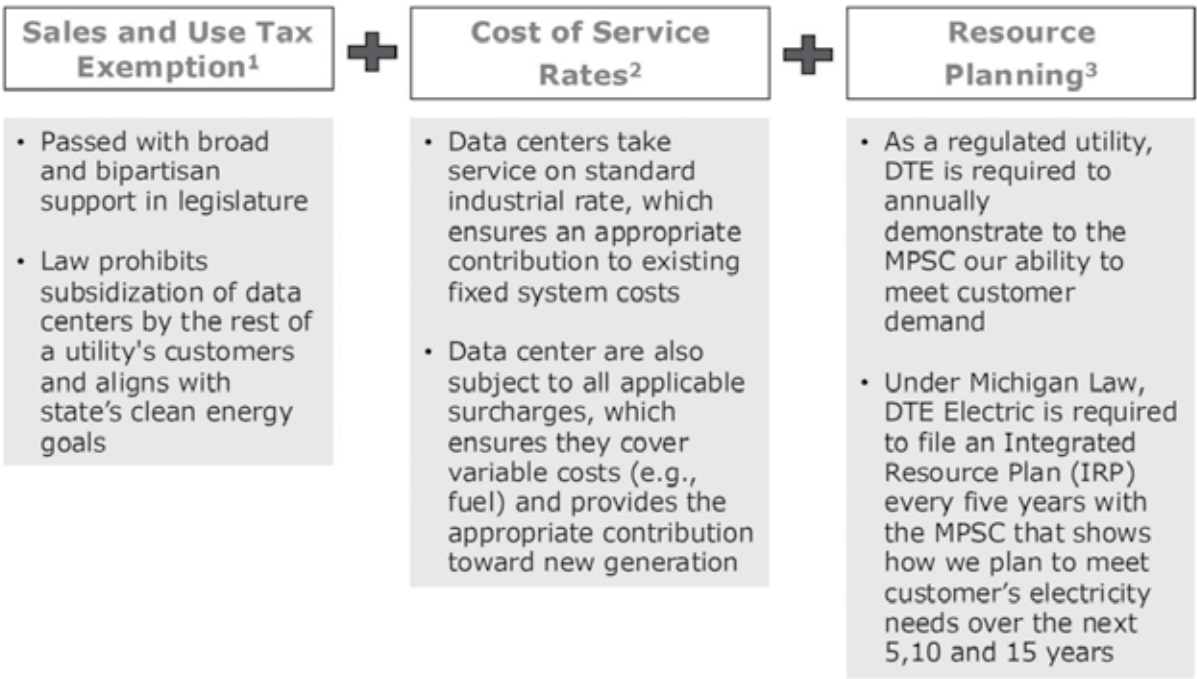

Data centers – and specifically the one proposed in Van Buren Township – will become major contributors to the investments DTE is already making in the distribution grid and our generation fleet, helping make our electric system more stable and resilient for everyone. Moreover, any costs associated with infrastructure unique to the data center will be paid for by the project and not passed on to DTE’s existing customers.”

Michigan has key laws and regulations in place that protect customer affordability and reliability as data center join DTE’s electric system



What is the Law That Prevents DTE From Passing Data Center Costs Along to Residential Customers?

What Does Public Act 207 of 2024 Say About Clean Energy?

A: The Public Act requires that a data center procure clean energy to 90% of the data center’s forecasted electricity usage on an annual basis. Clean energy is defined in the Clean and Renewable Energy and Energy Waste Reduction Act (PA 295 of 2008) and can be found at this link:

Who Holds DTE Accountable?

A: DTE is accountable to the Michigan Public Service Commission (MPSC). You can find more information on their website at: <https://www.michigan.gov/mpsc>

What is the length of the contract with DTE? (In regards to taxpayers not being responsible to subsidize the project)?

A: Per the developer, the ratepayer protection is in perpetuity, with no expiration. The contract length between DTE and the client will likely be 20+ years. When this is finalized it will be made public in a Michigan Public Service

• Heard commission chairman Cullin say he agreed with Jahr. He said he has been on the board for five years and members attend planning conferences to gain knowledge. He said his great-grandfather was treasurer of the township at one time. Cullin said the township is going to have problems, but “driving through Canton is a nightmare... We try to control what we see in Canton. Try Rochester.” He said the consultants give 100% and, “Thank God they’re here”;

• Heard Jahr continue his comments, with, “Data centers are a big project ... I have worked in the data center industry. The change in the last 10 years is very profound ... The power density is much higher by ten times. He said it’s like suddenly running ten refrigerators in a house. Would need more air conditioning. This is change that happened recently, less than 10 years... Technology is changing quickly ... and we have to act to protect the residents...;

• Heard McKenna consultant Krishnan say that what is in words in the zoning ordinances can’t be taken away. The commercial and industrial uses named can’t be denied because then it is taken to court and the residents pay. She said planners are going to look at the ordinance and part of that is to look at what other communities are doing; and

• Heard Akers say the zoning ordinance is never going to be perfect and “upgrading is what we’re doing.” Budd said the township is looking at a moratorium for other data centers. “The first one is on track,” she said.

Absent from the Jan. 28 meeting were commissioners Medina Atchinson and Bernie Grant.

Sumpter Township sells two properties it owns on 5-2 split vote

After a heated discussion at its Jan. 27 meeting, the Sumpter Township Board of Trustees voted 5-2 to sell two pieces of township owned properties to the same person, who was not announced.

The 67 acres on Rawsonville Road (81-122-99-0007-701) went for \$300,000 and the smaller parcel on Martinsville Road (81-102-99-0006-000) went for \$200,000.

Voting no were trustee Matthew Oddy and treasurer Bart Patterson. Yes votes came from supervisor Tim Bowman, clerk Don Laporte, and trustees James Frazier, Tim Rush, and John Honey.

After the vote, supervisor Bowman announced: “Done deal!”

“We were willing to take \$450,000 on that,” Oddy said. “\$300,000 is 60% of what we wanted.” He said the township should advertise it as such if it would give

a land contract.

Treasurer Patterson said the township had owned the Rawsonville property since 1984. He said he asked himself what he would do if it was his property. He said it took him two and a half hours to find out information on the parcel. He wondered if it was a treed lot, with oaks? The value of the trees could be taken into account, he said.

Oddy said they sold the Moose Lodge on land contract and that fell apart. He said the Martinsville Road property had extensive environmental contamination.

Clerk Laporte said both property sales should be on one contract, so if one fails, they both do. The board agreed to this.

In other business at its Jan. 27 meeting, the board:

- Under open floor discussion, heard Gary Lloyd of 21187 Sherwood Rd. tell the board again that he and his wife has to pay \$4,000 for a study that wasn't necessary after someone from the township called the state to say they were building on wetlands, which wasn't true. This halted construction of their barn and he wants the township to make them whole and reimburse them the \$4,000. Township attorney Rob Young said the township doesn't have the authority to reimburse. Lloyd said this cost was caused by the township. The planner didn't call and he said he thought it was ordinance officer Pete Gregory who was getting back at them. Lloyd said after Gregory "mouthed off" to his wife, he threw Gregory off their property. Two weeks later their construction was stopped, although they had all the permits needed. Attorney Young said there was nothing they could do by law and it was just speculation that Gregory called the state. But Lloyd said they had insurance for making bad decisions. He said he would file a Freedom of Information Act request to find out who called and the state said it was the building department, but wouldn't tell him who. "I'm a licensed builder and I've never seen anything like it before," he said;

- Heard Cheryl Norden of The Bake Shoppe complain about Sammy's Auto Sales next door in what used to be the Hughes business. She said he has blocked the traffic so her deliveries can't leave. She said owner Hassan Nassar said she brought in two semis of dirt to fill in the county ditch for access. She said that didn't happen. She said she filled in the drive in front with gravel from the back of her property. She said the county installed that for her years ago, with a county ditch and two basins. That's because her property flooded when they bought it after it was vacant for ten years. She said Sammy said she installed 20 cameras to watch him, but for the past 21 years she has had an "observation deck" to tend to equipment on the roof and she can see for a great distance. She said she climbs a five-step ladder to get there. She does have cameras, as well. She showed a

Commission (MPSC) filing.

What size power lines will be feeding the project, and will there be any redundancy to minimize the use of generators? How frequent do you anticipate the generators will run in order to provide needed power to the project?

A: Per DTE, two 345 KV transmission lines will be cut in to provide four feeds to the new transmission substation on site. In at least the past 10 years, there has not been an instance where both lines were out at the same time. This suggests unlikely use of on-site backup generation.

Infrastructure Improvements

Is the Township Paying for Infrastructure Upgrades for this Project?

A: No, the Township is not funding any of the improvements for this project. The applicant will be responsible for the costs of installing infrastructure to the site. The only thing the Township may pay for is a meter pit for the new connection to the GLWA transmission main. Details of this are being discussed currently.

Public Health Concerns

What Are Common Public Health Concerns Related to Data Centers?

A: Nationally data centers have been getting a lot of attention from news outlets related to public health concerns. These public health concerns have been related to well water contamination, noise, use of chemicals in cooling processes, and air pollution from back-up generators. Additional details about how these concerns will be mitigated are below. The developer has stated that while the scale of data centers is new, the technology used to manage their impact is often more advanced and more regulated than traditional industrial manufacturing sites.

What is Van Buren Township Doing to Protect Its Residents from Noise Related Issues?

A: As a part of the site plan review process, Van Buren Township has required the applicant to provide a noise study which indicates how much noise is generated from the mechanical equipment on the property and what impact that would have on adjacent properties. As mentioned above the Township has standards in the Zoning Ordinance that limit the amount of noise (dBA) at a property line adjacent to a residential property. We will review this study to ensure that it is compliant with the Township's zoning standards related to noise.

What is Van Buren Township Doing to Protect Its Residents from Water Related Issues?

A: For this project, the water will not be taken from any groundwater, surface water, or aquifer but it will be purchased from the Township through a Great Lakes Water Authority (GLWA) Transmission Main. This is also required **under Senate Bill 237 (SB 237) and House Bill 4906 (HB 4906)** which requires the use of municipal water at the time the facility is placed in service. The water would be obtained from the Southwest Treatment Plant which sources its water from the Detroit River. Additionally, there is no process or sanitary sewer water proposed to be treated on site and discharged to any groundwater, surface water, or aquifer. Any sanitary sewer or process water will be discharged to the Township's sanitary sewer system which will outlet back to the Detroit River through the South Huron Valley Utility Authority Waste Water Treatment Plant in Brownstown Township near Gibraltar, Michigan.

There will be onsite stormwater detention for paved areas which will outlet to existing drains on and/or adjacent to the property, but it would be illegal per Township Ordinance, County Ordinance, and State Law for this water to be connected to the process water or other sanitary sewer water in any way.

There are no proposals to draw water from or discharge any cooling water to ground water, surface water, or aquifers on site. If there were any future proposals after the development of the site, they would require substantial environmental review, permitting, and public outreach by EGLE to obtain a permit to do so.

What is Van Buren Township Doing to Protect Its Residents from Air Pollution Related Issues?

A: There is no fulltime onsite power generation proposed as a part of the project. The only power generation items that are proposed on-site are a series of on-site backup generators which are intended to be used during outages. The Township does not have specific guidelines for air emissions and our zoning ordinance refers to federal clean air standards and the state provisions in the Michigan Natural Resources and Environmental Protection Act of 1994 (NREPA). EGLE has a permit process and guidelines to review air emissions. To see more information about EGLE's

- Approved Public Safety Director/Police Chief Eric Luke and three command officers to attend the MACP Winter Professional Development Conference in Grand Rapids on Feb. 4-6. Cost of conference is covered by state-provided training funds; and
- Went into closed-door session to discuss the AFSCME contract and the attorney's written opinion on another matter.

Before the Jan. 27 board meeting at 6 p.m., the board held a special 5 p.m. meeting to discuss Judd Road improvements with Wayne County Commissioner Allen Wilson. The other officials from Wayne County expected to be present did not attend. They had been told the 2.3 miles of paving would cost \$1.7 million. The agreement appeared to be that the township and the county would share the cost 50-50 and the county would pay no more than \$1 million. The township was asked for \$1 million

Generator Operation & Environmental Impact

How often do the generators run and will there be smoke or odor?

A: Per the developer, the onsite generators are strictly for emergency backup and are only 'active' during power outages. Monthly testing will occur. These tests are scheduled during daylight hours to minimize disruption. At most, two generators will run simultaneously for one hour per month as part of maintenance operations. The end user will use Ultra-Low Sulfur Diesel (ULSD) and high-performance exhaust scrubbers that remove 90%+ of particulates. At the property line, there is no detectable odor or smoke. Furthermore, the generators are Tier 4 Final compliant—the EPA's highest standard for clean air.

What is the lifespan of the facility and how is equipment disposed of?

A: Per the developer, the building infrastructure has a 30- to 50-year lifespan. While the servers inside are refreshed every 3–5 years, the facility itself remains a permanent, tax-paying asset.

Disposal: Per the developer, the end user has zero-waste to landfill goal and a robust electronic waste program - prioritizing reuse, refurbishment and recycling. Its commitment also extends beyond hardware to include all operational waste, such as packaging and even food waste. Outdated IT equipment is wiped of data and recycled off-site for precious metal recovery.

Other Questions

How Does This Project Benefit the Community?

A: Some benefits that the community can see from the development include:

- Creation of approximately 1,500 construction jobs and 51+ permanent jobs.
- The developer and project user have indicated that they are committed to recruiting locally for employment.
- Adding a large volume water user to the system is a benefit to the customer base because it adds large amount of revenue to the system which has a positive effect on overall customer rates.
- Large increase in property tax revenue related to the project.
- The addition of a new Fortune 50 company to the community that has a track record in other states of engaging with local schools and being an active community member.
- The installation of large berms along Haggerty Road will limit any visual impacts of the project from Haggerty Road. Other buildings have large setbacks from roads adjacent to the property.
- The use does not have any trucking associated with it. It will have a limited impact on adjacent roadways.
- A large amount of the property (approximately 47%) will be left as undeveloped open space.
