## VBT drive-by shooting July 5 injures 1 on Greenwood in VBT

At about 1:30 a.m. on July 5, Van Buren Township Police responded to a report of a shooting on Greenwood Court in the subdivision at the corner of Belleville and Van Born roads.

The male victim, a 44-year-old Ypsilanti resident, was at a local hospital with non-life-threatening injuries, said Van Buren Township Deputy Police Chief Jason Monte.

The residence was hosting a Fourth of July party, and both the victim and suspect were in attendance. There was some sort of disagreement at the party, which resulted in the shooting, Deputy Chief Monte said.

On Monday, Monte said police were still actively working the case. He said this was an isolated incident, as police know both the suspect and victim were familiar with each other.

Neighbors reported a man was taken to a hospital by friends after the shooting on Friday. They said a group of neighbors from one house were shooting off fireworks in the street until around 11 p.m. on Thursday's Fourth of July holiday.

Later several shots were heard in a row, followed by screaming. Neighbors assumed the shots were more fireworks until someone called out a man should be taken to the hospital and they left in a vehicle.

Others, who were at the original fireworks, scattered on foot and in vehicles, neighbors said

Someone called Van Buren Township Police who arrived and stayed around investigating until after 9 a.m., neighbors said. Some individuals were seen in the backs of police cars.

Monte said on Monday that police were still in the process of tracking down witnesses and awaiting the forensic results from search warrants.

## Fire destroys home on Sheldon Road with no injuries on June 29

There were no injuries in the fire that destroyed a home on Sheldon Road in Van Buren Township around 7:08 p.m. on June 29, but a family with eight children was sent to a hotel to stay with everything they owned lost in the blaze – except what was out in the backyard.

Fire Chief Dave McInally said his fire fighters were first on the scene and there was a hydrant that was out of service, but they were able to put out the fire immediately with the water on the truck.

Backup came from fire departments in Belleville and Sumpter Township.

Chief McInally said that was the same night as the fireworks in Van Buren Township and he had crews at the scene of the fireworks, but also had a team to cover the rest of the township. Belleville Assistant Fire Chief Chris Zweng said Channel 2 news thought the fire was in Belleville and broadcast that information, but it was in the township, but right next to Victoria Commons in Belleville.

Chief McInally said there was significant damage to the home and one room was destroyed. The fire inspector said the start was electrically oriented, but it was unknown whether it was from wiring in a ceiling fan or a wall outlet.

He said the door to that room was open, so the fire spread.

Martha Dejesus told Channel 2 news that she and her partner Jacob Hixson have eight children, all girls, ranging in age



## **EXTRA THINGS I KNOW**

A television channel last weekend told a long story about a fire in Belleville that displaced a family of 10, including eight children, on June 29. They had a picture of the Belleville Fire Department for some of the reporting.

But, it was learned that the fire was actually in Van Buren Township, on Sheldon Road, which runs just east of Victoria Commons. Victoria Commons is in Belleville, but Sheldon Road is in VBT.

The fire victims reportedly told the television reporter that they lived in

And, such it goes. When someone says they live in Belleville, they could actually live in the city of Belleville, Sumpter Township or Van Buren Township. They all carry the 48111 zip code. The post office building is in Van Buren Township on the South I-94 Service Dr. It used to be in the city of Belleville. It still says Belleville Post Office on the building.

A few years back, VBT Clerk Leon Wright got the mailing address for Van Buren Township to be officially changed to Van Buren Township. It is still in 48111. It was to give Van Buren Township an identity. Well, many people had a fit. Their insurance companies had problems with it. The Wall Street Journal couldn't deliver to the right address. Confusion was rampant.

Well, that has calmed down a bit. Now, people just sigh, throw up their hands, and obediently say they live in Van Buren Township, but add that they'd like to say they live in Belleville because that's where they have always lived.

People in Sumpter Township still live at a Belleville address and so do the city of Belleville residents. It's all still 48111.

We remember a candidate for a Belleville

office who got most of the signatures on

her petition for the ballot from Van Buren

Township residents, so it was rejected. People new to this area may think they live in Belleville. Maybe they do. They get off the freeway at the Belleville exit, don't they? This is all to say that when people say something happened in Belleville, maybe it did and maybe it didn't.

One of the owners of the Geese Chasers who rid Horizon Park of the Canada Geese that had lived there for so long was before the Belleville City Council last week for an update on his work.

He told them he was called by assistant city manager Steve Jones last March. He said that he and his wife and their Border Collie Bracken were running the business. He said Bracken arrived home from the trainer and there was a surprise. She was pregnant. Now they have two dogs.

He said they also chase geese at the Costco depot in Van Buren Township along with French Landing and Quirk parks in Van Buren Township.

"I think they are gorgeous and really smart," he said of the geese. But, he said, they do love suburban areas, neatly cut grass and water. He said since the city doesn't want to let the grass grow high at Horizon Park to drive them off, he is bringing humane solutions.

A neighbor thought driving them off during the nesting season was not humane. She

questioned whether he really had a permit from the federal government to destroy the eggs and nests. Another man who drives by every day said the mallard ducks who used to live in the park also are gone.

Those putting on the Lakeside concerts report the grass is clean now because the geese are gone. Concert-goers can now bring a blanket to sit on the grass instead of having to carry in a chair to keep away from the goose droppings.

As part of its regular 2 p.m. meeting on Tuesday, July 9, the Van

Buren Township Local Development Finance Authority (LDFA) was scheduled to take a tour of the newly constructed Community Center. The agenda was very light, so they added the tour.



Our Aug. 6 ballot in the 48111 area contains two proposals, three if you live in Sumpter. It asks voters to renew the Wayne County millage for parks, part of which each municipality gets back to spend on its own parks. Wayne County also asks to approve an amendment so that the external auditor selected by competitive bid can serve for three years or more. Sumpter voters are being asked to approve up to two mills for

four years for fire protection.





She currently is the director of a regional office that administers 🐧 the indigent defense programs for 20 of Wayne County's 24 third-class district and



municipal courts including 34th District Court. The program provides appointed attorneys and defense resources for those in need of public defense.

"I have been the indigent defense administrator for 34th District Court for the past 5 years," she said. "Over the course of the last approximately 20 years I have served as the state prosecutor, a court appointed attorney, and now the indigent defense administrator for 34th District

She also is an adjunct professor in the Political Science Department at Wayne County Community College and a student instructor in the Political Science Department at Wayne State University.

In 1996, she earned a Bachelor's of Business Administration at the UofM Flint (Angell Scholar, Maize and Blue Distinguished Scholarship Recipient). In 2000, she earned a Juris Doctorate from Wayne State University. Currently, she is an ABD (all but dissertation) PhD student, in Political Science at Wayne State University.

She is a member of the Black Women Lawyer's Association, member of the National Association of Public Defenders, board member of the Jeremy D. Stovall Splurge Foundation in Belleville, and member of the Greater Romulus Chamber of Commerce, Westland Comets Football Team field director, former Cheerleading Coach at Metro Charter Academy in Romulus, former den leader for Cub Scout Pack 9885, and previous legal director for Safe Assurance, Inc., a non-profit organization where they provided pro bono legal assistance to women and children affected by domestic abuse.

She explains why she is running for this

"When I learned there was going to be an open judicial seat at 34th District Court and I contemplated running to fill it, I thought long and hard about what qualities are necessary to serve as a good judge of the people. Those who appear before the court at 34th District Court are entitled to a judge who will serve with judicial virtues such as legal and personal integrity, impartiality, timeliness, attentiveness and who promotes equal access to justice for everyone with a proper temperament of fairness, courtesy and respect.

"Serving with judicial virtue and proper temperament is an important responsibility because judicial decisions have a direct impact on individuals and the business community by deciding the rights and

obligations of litigants, and they can impact future actions, freedoms, possessions and

"I have 24 years of diverse legal and personal experience that gives me the expertise to serve as judge with legal excellence and judicial integrity to include working as a Wayne County Assistant Prosecuting Attorney, a private practitioner in various areas of the law, a public defender, a pro-bono advocate, and a public defense administrator.

"Throughout my career, I have represented my clients with zeal, legal wisdom, integrity, attentiveness, fairness, and respect. Thirty-fourth District Court is the court of my community and I have served as its state prosecutor, court appointed attorney and now its indigent defense administrator. I am running for judge because I desire to make a difference and to continue investing my legal expertise in a new capacity - as judge of the 34th District Court."

She was asked what she thinks are the most pressing issues in this court and what should be done about them?

She replied: "Our court is tasked with adapting to the changes Covid-19 and recent criminal justice reforms have brought about. The way courts do business has changed drastically in the past few years. First, Covid-19 introduced virtual court which created issues with court logistics, technology, communication and court etiquette.

"Courts, litigants, attorneys and other stakeholders have had to figure out how to handle court business effectively and efficiently while still maintaining legal integrity. Some have had difficulty with new technology requirements such as zoom and zoom break-out rooms. Communication has also become a challenge as people had to figure out how to exchange information that would have been typically exchanged in person in the courthouse.

"Things like introducing evidence during a hearing or trial also needed attention. Lastly, virtual court proceedings have strained court etiquette since attorneys and litigants are "doing court" from the comfort of home and offices. The court has been attentive to the changes and has formulated policies and procedures to address these issues and it will be necessary for everyone to work together to implement them.

"While continuing to focus on proper application of the law and resolving disputes, the court will need to collaborate with attorneys and community stakeholders to find solutions that are best for everyone involved. Clear communication is key as well as educating court staff, attorneys, police agencies, other stakeholders and the public on their pertinent issues and the solutions. Mutual patience and respect must also be present.

"In the same vein, criminal justice reform and court rule changes have altered the way courts handle proceedings as well. The best course of action here is the same as with the Covid-19 changes --attentiveness to the changing state of reality, collaboration, adaptation by developing processes and procedures as solutions, open communication, educating all involved, and mutual patience and respect."

He said he is running "to represent the values of my friends, family, and neighbors and give them a voice in our government. I'm a husband, a father of three, and a grandfather of four. 





These ideas were realized with the reopening of the Van Buren Community Center in June 2024 and the expansion of the full-time, paid fire fighters.

When asked about his goals once he is elected, he replied:

## Belleville City Council gives immediate raise to its clerk/treasurer

A raise in salary from \$62,000 to \$75,000, effective immediately, was given to the Belleville City Clerk/Treasurer Brianna Hootman on a unanimous vote of the city council on July 1.

This was at the recommendation of city manager Jason Smith, who noted that on the Council of Western Wayne salary list, Hootman's pay was the lowest of the fulltime clerks on the list. She said her last raise was in August of 2021 and she had been working under an "agreement."

Councilman Jeremiah Beebe was the only councilman absent July 1.

The agreement said the rate of pay is \$75,000 per year/\$36.058 per hour and her pay shall be adjusted on an annual basis after finding of a satisfactory performance review by the city manager. The clerk/treasurer is a salary-exempt position for overtime. She will provided health insurance benefits equal to those of the members of the GELC collective bargaining unit.

DPW Director Tony Bollino said he thought the salary should be raised to \$78,000 because she does the work of both the clerk and treasurer in the combined job. The CWW list only listed clerks, not the combined jobs.

"We need to be competitive in the market to keep top people," Mayor Ken Voigt said of the raise. "It seems like a lot, but we did budget for this."

In other business at the almost two-hour meeting on July 1, the council:

- Approved the second reading and final adoption of a zoning ordinance amendment to allow banquet halls in B-1 zoning locations for buildings less than 2,500 square feet. It will be in effect 30 days after passage;
- · Tabled to the next meeting for more information selection of a water meter contractor from the three selected bidders. Also, Mayor Voigt said he would like all five council members to be present for the important decision. Representatives of ETNA Supply and Ferguson Water Works were present to answer questions. The third bidder, SLC Meter, was not represented. Bids were \$590,544.13 by Ferguson for Neptune brand meters; \$612,683.85 from SLC Meter for Badger meters; and \$628,006 by ETNA for Sensus meters. The recommendation from the staff was SLC. The present meters are 12 years old, but their technology is 30 years old, Smith said. He said they can't get parts and there are problems with the collector. The company that made them no longer exists.
- Approved the purchase agreement for the sale of the city's former DPW site at 100 Davis St. for \$50,000. Buyers Sam Arndt and Leah Stempky, on behalf of an entity to be formed, agree to take over responsibility for the contamination left on the site, which has test wells. The parcel adjoins their Burhop's Collision site;
- Approved placing four amendments to the Belleville City Charter on the Nov. 5 ballot including: allowing the council to set the time and date of the meetings roll-call votes eliminated, except for financial spending; allowing the council to set the purchasing policy and when bids are necessary; and removing completely

the civil service commission, which now only covers the police chief and the clerk/treasurer;

- Approved lease of a Tymco 300 sweeper;
- Tabled for more information a proposal to buy a new tornado siren for \$27,900 from Westshore Services, which is the same company used by Van Buren and Sumpter townships. Smith said that would put 48111 all with the same sirens. Smith had been asked to look at grants available and he said the MMRMA (Michigan Municipal Risk Management Authority) didn't get back to him and other grants open in October for Homeland Security and private grants. Mayor Voigt asked him to at least put it out for bids;
- Approved accounts payable of \$61,703.65 and departmental expenditures of \$500 or more: to City of Williamston, \$779 for outer carry ballistic vest for Officer Michael Pearl; to Core and Main, \$555 for sewer cover replacement rings; to Harold J. Love and Associates, \$1,500 for psych evaluation for Officers Charles Brooks and Michael Pearl and \$750 for psych evaluation for Officer Marc Boudreau; to Monroe County Firefighters Association, \$3,400 for 2024 association dues and chief dues and firefighter training; and to R&R Fire Truck Repair Inc., \$5,239 for fire truck lettering;

# Judge Cylenthia Miller accused of carrying loaded gun at airport

Wayne County Circuit Court Judge Cylenthia LaToye Miller of Flat Rock was scheduled for a July 1 arraignment/pretrial at 34<sup>th</sup> District Court on a charge of a check-point violation at Detroit Metro Airport at 10:01 a.m., June 8.

The arraignment/pretrial was adjourned until July 15 before Judge Lisa Martin.

Transportation Safety Agents reported she carried a loaded firearm through Detroit Metro Airport. They alerted airport police who levied the charge.

She has been a judge in Detroit since 2006 when she was appointed to the position. She spent 13 years on the bench at 36<sup>th</sup> District Court and the last five at Third Circuit Court where she now presides over juvenile court.

On June 8 while she was on her way to catching a flight, Miller passed through security at Metro Airport and the TSA found a gun in her purse on the x-ray scanner. It was a loaded .380 caliber Smith and Wesson firearm.

Miller's defense attorney Todd Perkins, who said he was a personal friend, told channel 7 news that Miller is a licensed CPL holder and can lawfully possess, in a concealed fashion, a firearm in the state of Michigan.

But the law prohibits a person from carrying a loaded firearm in carry-on.

Channel 7 reported that sources told it that Miller told airport police that the gun had belonged to her brother, who lives in Ohio and Ohio does not require that firearms be registered.
